

# BUILDING SOCIAL PROTECTION FLOORS WITH THE ILO TOGETHER, TO CHANGE MILLIONS OF LIVES IN PARAGUAY

## INSUFFICIENT SOCIAL PROTECTION COVERAGE

With almost 7 million people, Paraguay is the one of the smallest countries in South America. Total poverty has been decreasing over the last several years. In 2017, 21.6 per cent of residents were living in poverty, with extreme poverty affecting 6.0 per cent of the population.

Despite successful economic performance in the recent years, Paraguay has low social security coverage among the economically active population. Approximately 2.5 million of workers are not covered by social security, which represents 78 per cent of the total workforce in the country. Access to benefits and services is still difficult; more than 63 per cent of salaried workers aged 15 years and above are not effectively covered by social security, with even higher figures in rural areas.

Paraguay has the will to better protect its population by implementing new social protection schemes. In October 2015, a new law specific to domestic workers was put into effect, modifying their working conditions to be consistent with the ILO's Domestic Workers Convention, 2011 (No. 189), which was ratified by Paraguay. In 2018, the government launched "Vamos!" a social protection system with an integral and life cycle approach based on social assistance, economic inclusion and social security.

## EXTENDING COVERAGE TO THE INFORMAL AND FORMAL SECTORS

While some gaps remain in both legislation and national practice, Paraguay is in a position to ratify the ILO's Social Security (Minimum Standards) Convention, 1952 (No. 102). The country might consider implementing some of the standards listed in the Convention by making some adjustments to their legislation and practice.

In addition, social partners are currently discussing ways to incorporate elements of the ILO's Social Protection Floors Recommendation, 2012 (No. 202), into the national



social protection system. Among the challenges are the need to promote access to information on the social security system for employers and workers, to better control the registration and payment of contributions through enhanced social security administration, to develop statistical capacity to monitor social protection and enhance decision making, and to strengthen the social and financial sustainability of the different components of the social protection system.

The Government could also consider implementing reforms aimed at strengthening the legal framework and institutional capacity to extend social protection and ensure its sustainability. The process of creating an integral and effective social protection system is not an easy task. Therefore, Paraguay needs technical assistance to extend social protection to its entire population.

## NATIONAL DEVELOPMENT PLAN 2014-2030

In September 2018, Paraguay launched “Vamos!” the Social Protection System (SPS) with the objective to guarantee rights to social protection throughout the life cycle. The SPS recognizes that social protection is fundamental for development and will coordinate and articulate the different government interventions under three pillars: social assistance, economic inclusion and social security. The development of the plan received the financial and technical support of the European Union. The plan works under the auspices of the Gabinete Social which counts with the participation of the Ministers of Labour, Health, Social Development, Finance, among others.
