## Social protection: a key to reduce poverty and foster growth

Southeast Asia has witnessed remarkable economic growth over the past decade. It has also achieved significant progress in reducing poverty. Even so, the number of people living on less than US\$1.25 a day was estimated to be 76 million in 2010.

Within this context there is a growing consensus in the region that the establishment of social protection floors is key to accelerate the reduction of poverty and inequality and to promote inclusive and sustainable growth.

Despite different paces and heterogeneous levels of coverage, most of the countries are now moving towards establishing sound policy and institutional frameworks to deliver efficient and effective social protection measures.

### Southeast Asia is a beacon for good practices

In recent years the region has been home to exciting developments and innovations in the area of social protection. Thailand is today a worldwide reference in the universalization of health coverage. Countries like Indonesia, Thailand, Mongolia and Myanmar were in the forefront of developing and implementing SPF Assessment Based National Dialogue methodologies. Indonesia and Cambodia innovated in the development of Single Window Services bringing together elements of social protection and employment services, and Viet Nam and Thailand are regional examples of unemployment insurance. But while the sub-region boasts many good practices and innovations, there remain significant social protection needs in several countries.

## But social protection is still far from being a reality for all

In countries like Lao PDR, Cambodia, Viet Nam and Timor Leste, the majority of people have no access to social protection benefits. The project strategy is to provide technical support to constituents through assistance to on-going processes of national dialogue, in harmony with coordinated efforts by UN and bilateral development partners.

It will assist the four countries (Lao PDR, Cambodia, Viet Nam and Timor Leste) in implementing the building blocks of nationally defined, owned and funded social protection floors. Depending on the particular area of intervention, the support will build on the experience and expertise of various master countries in the region.

Grounded in a regional peer learning process, the project will comprise practical support to national dialogue processes, design studies, and advice on the governance and administrative aspects of implementing national social protection floors, reflecting the principles of ILO Recommendation R.202 (2012) on national floors of social protection. This will allow countries to build tools to plan, budget, implement and monitor the performance of national social protection programmes. The project will also ensure wider dissemination of findings to other Southeast Asian countries and beyond, promoting a South-South learning approach.

protection that is a basic human right [...].
