#### Behind the Scenes

Three hot topics have been on the MNSSP agenda over the past couple of months. Below is a brief summary of what is going on behind the scenes at the MNSSP.

#### MNSSP Review Process

Over the past few months, coordinators and implementers have been meeting in workshops to assess the current performance each programme component of the MNSSP. Using a traffic light evaluation system, critical areas of work have been identified to guide the development of MNSSP II. Review meetings have also been held on the linkages between MNSSP interventions and other sectors (e.g., agriculture) and will feed into the overall review exercise. A final review report will be completed by the end of November.

#### Unified Beneficiary Registry

The Unified Beneficiary Registry (UBR) is a webbased national management information system and

database used for storing, accessing, analysing and sharing beneficiary household data. It is designed for use by those implementing social support programmes for targeting, linking, monitoring and producing periodic reports on the outreach and implementation of programmes. It offers information on the number of beneficiaries being reached by a programme and is a common sharing point for other systems to obtain household data for their programmes. In collaboration with the UBR Task Force, a consultant has developed an interview guide tool for harmonised data collection, which was successfully tested in two traditional authorities (TAs) in Phalombe. The exercise included training of district staff and enumerators on data collection. A total of 100 households in Jenala TA and Chiwalo TA were sampled during pretesting to ensure the appropriateness of the tools and consistency of questions in the interview guide.

A validation workshop on the harmonised data tool was conducted in the first week of September. In addition, the long-anticipated production process is expected to start with the Development Pathway of Kenya joining the team in the step-by-step process of coding, development and implementation. The production process is expected to run for eight weeks with further components to be upgraded during the support and maintenance phase.

#### Social Support Fund

The Ministry of Finance, Economic Planning and Development, with support from GIZ, commissioned a feasibility study to explore options for the creation of a common funding mechanism for the MNSSP to be known as the Social Support Fund (SSF). The SSF is expected to contribute to (1) greater harmonisation and strategic alignment of MNSSP activities with Government of Malawi policy; (2) more predictability of resource flows to the MNSSP; (3) better coordination resulting in a reduction in transaction costs and; (4) greater flexibility in implementation of MNSSP activities. Stakeholders validated the study report on 11 July 2016 in Lilongwe. The report sets out a roadmap of incremental improvements to increase financial coordination to enable the sector to move towards the establishment of the SSF in the medium term.
