## A POPULATION WITH LITTLE OR NO SOCIAL PROTECTION

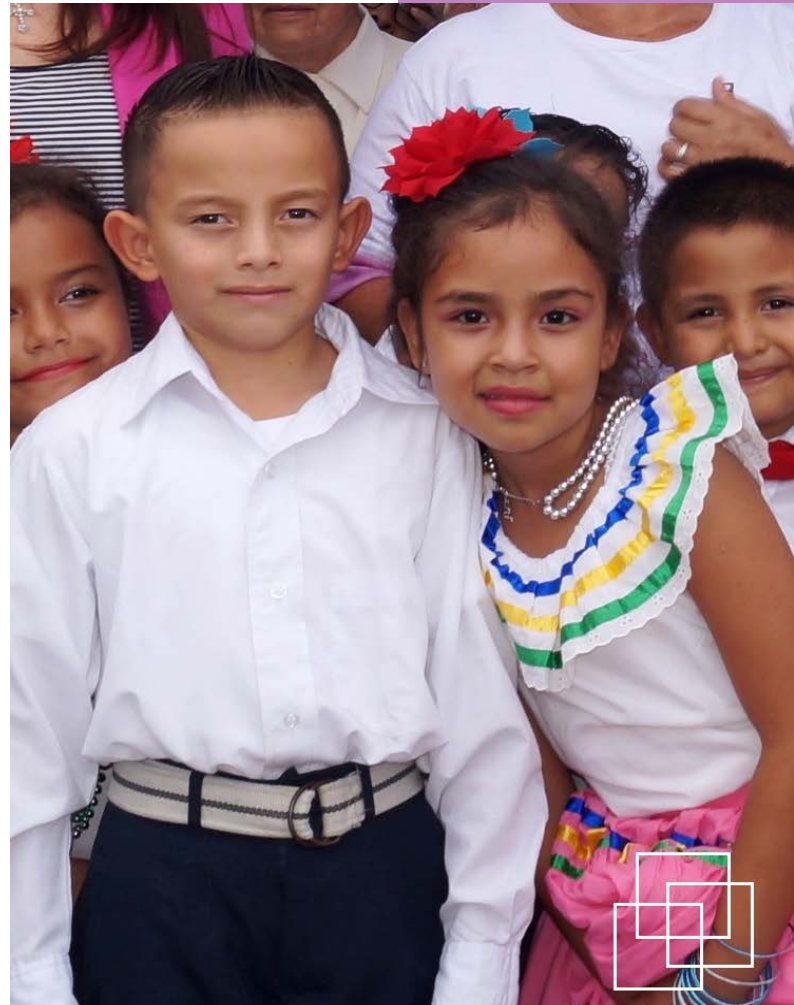
Honduras is a lower-income country in Latin America and the Caribbean region. In 2013, extreme poverty among households was 42.6 per cent, 29 per cent in urban areas, and 55.6 per cent in rural areas. Socio-economic circumstances in the country make it imperative to establish social protection programmes which can have a positive effect on the living conditions of people.

Honduras considers social protection for all a national priority. It invests 8.8 per cent of its GDP in social protection and has ratified the ILO's Social Security (Minimum Standards) Convention, 1952 (No. 102). However, the social protection system is still fragmented and leaves a significant part of the people without adequate protection.

## A LAW FOR UNIVERSAL COVERAGE

In May 2015, the National Congress of Honduras approved the Ley Marco del Sistema de Protección Social (Social Protection System Framework Law). The text of the Law refers to a social protection floor (SPF) that can protect the entire population and gives priority to poor and vulnerable Hondurans who need it the most.

The Law seeks to benefit approximately 6 million Hondurans living in poverty, as well as to extend protection to 78 per cent of the working population. Through the Ley Marco, Honduras strives to extend social protection to the entire population, thus following the established guidelines stated in the ILO's Social Protection Floors Recommendation, 2012 (No. 202).



The protection established by the Honduran national legislation goes beyond ILO Convention No. 102. However, coverage needs to be effectively extended. For example, even though national legislation provides universal protection for health and maternity care, in practice, only one employee out of every two is covered.

While the Government is committed to the expansion of social protection, the process of creating a new social protection system is not an easy task. Therefore, Honduras needs technical assistance to implement the Ley Marco and extend social protection coverage.

## LEY MARCO ENACTED 4 SEPTEMBER 2015

Article 5 of the Law states that a multi-pillar model should be created. This will consist of five schemes: social protection floor; contributory pension scheme; health insurance; workmanship compensation; and unemployment insurance.

In accordance with Article 7, "the social protection floor (SPF), is a non-contributory pillar that ensures access to essential services and social transfers, with emphasis on the poorest and most vulnerable people. Its approach incorporates the universal extension of social protection, but gives budgetary priority to the needs of the population suffering from poverty and high vulnerability."
