The Programme identified eight thematic areas that are key elements for building strong and sustainable social protection systems. The panel discussion will showcase achievements in making social protection schemes more effective through ratifying and applying international social security standards, strengthening legal frameworks, improving administrative and financial governance, leveraging adequate financing, and creating strong social dialogue and partnerships to advocate for universal coverage. Phase III – How to maximize the Global Flagship's contribution to accelerating progress towards the SDGs and beyond
