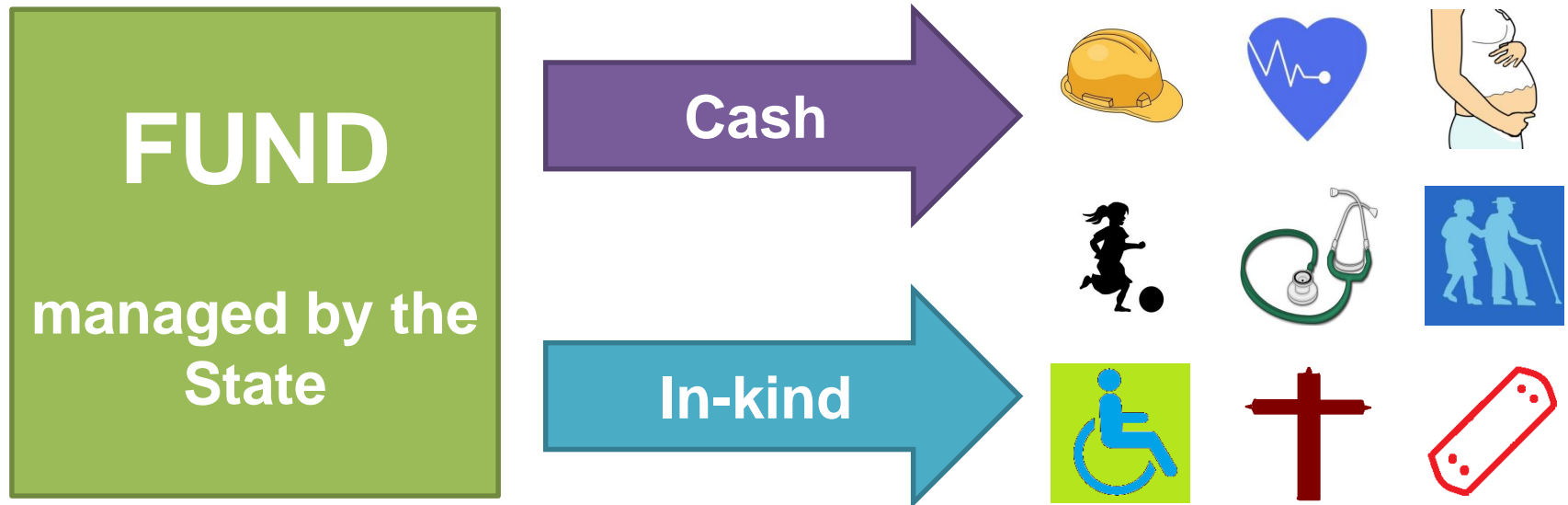
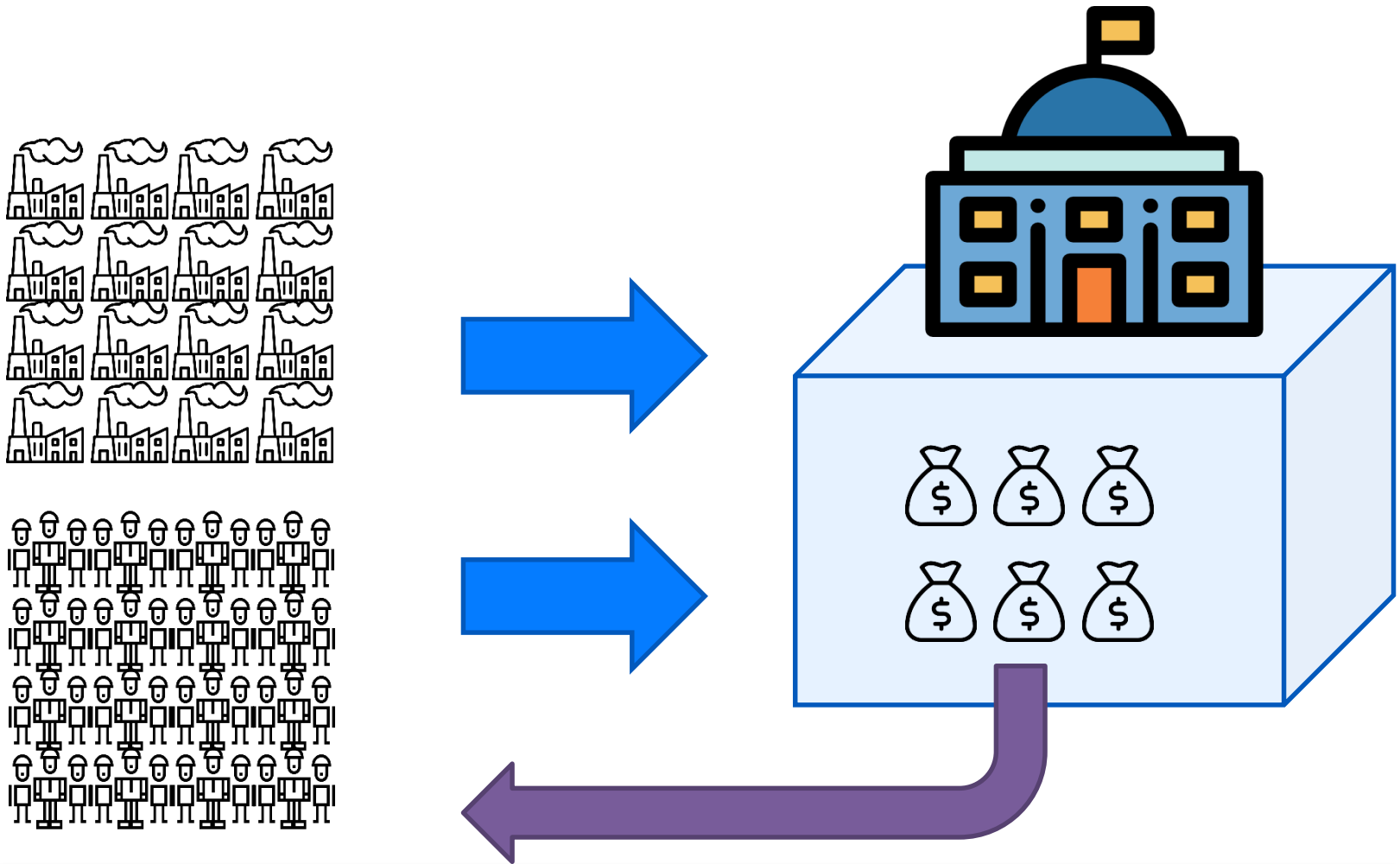
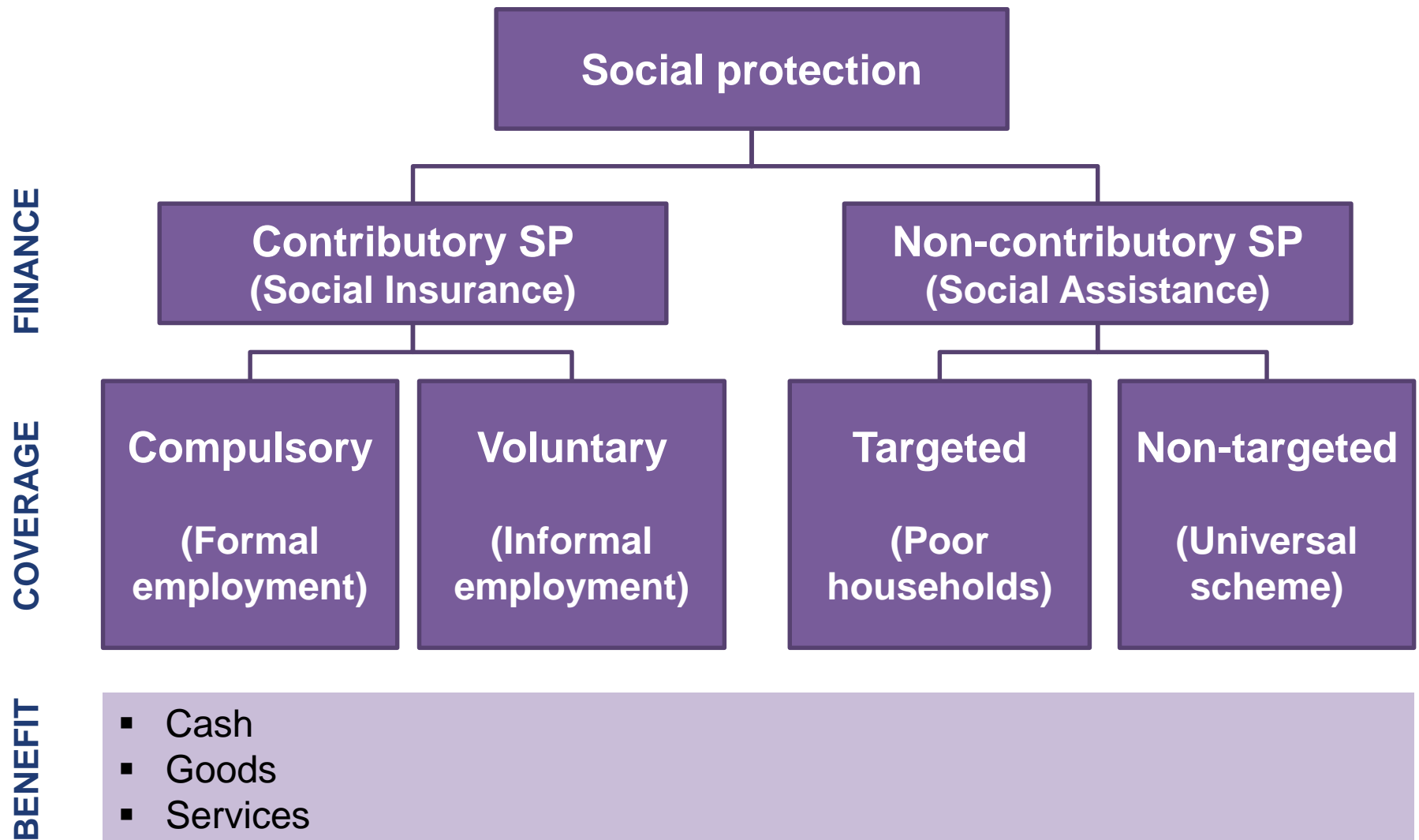


ILLUSTRATION: RISK POOLING

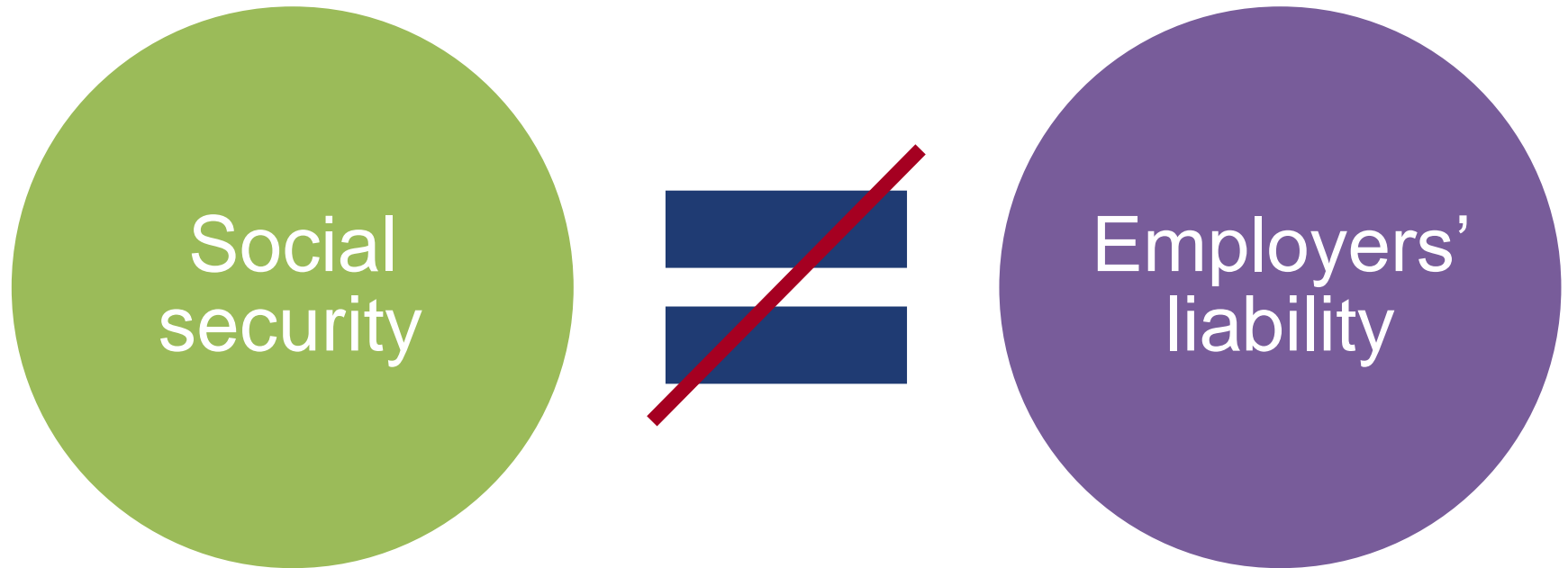

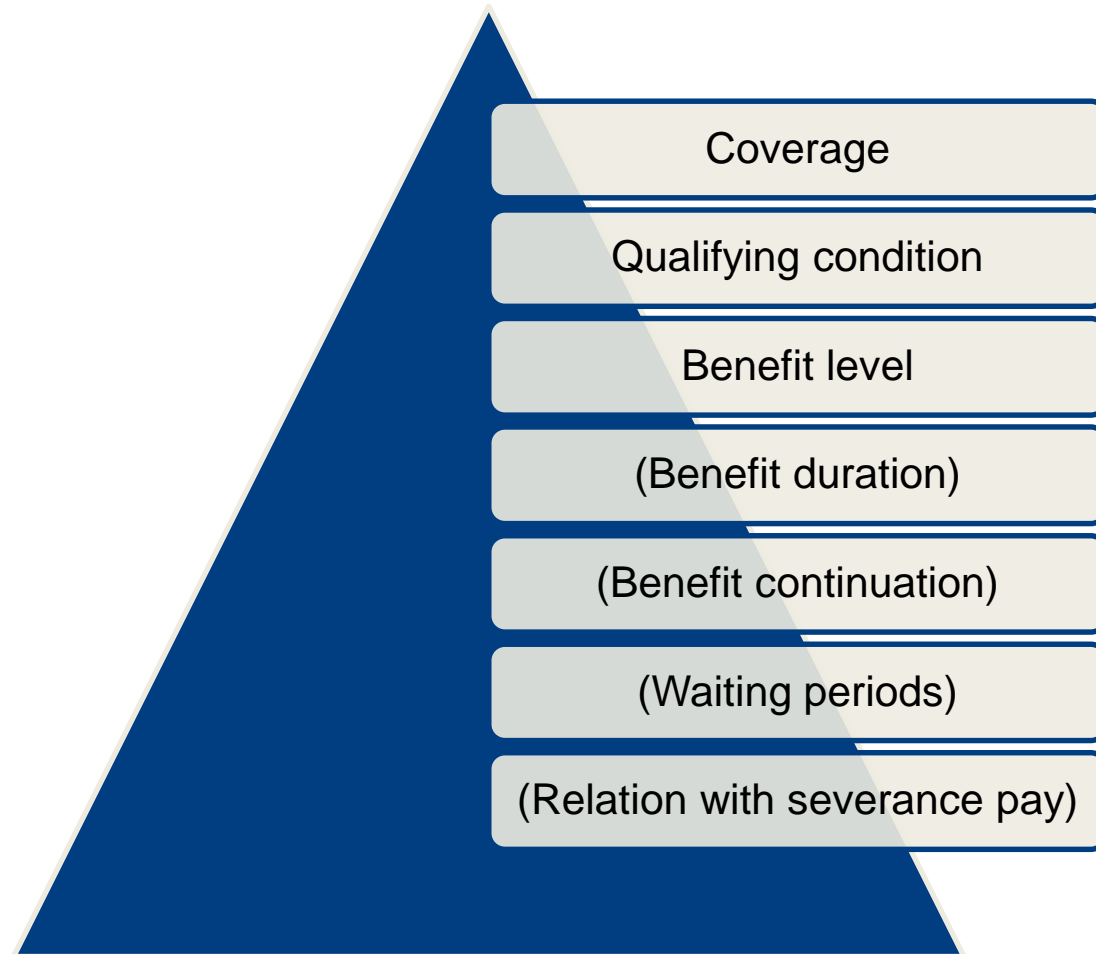
