Background

In 1963 the Statistical Office of the European Communities (SOEC) was committed to produce statistics at the "European Community" level in the area of social protection. In 1967 the SOEC started publishing regularly the data compiled by the Member States. After these pioneering activities, a more consistent system was developed in the late '70s: the European System of integrated Social PROtection Statistics (ESSPROS). The first ESSPROS methodology was published in 1981. In 1993, Eurostat undertook a general revision of the ESSPROS, in close co-operation with the Members States. The ESSPROS Manual 1996 was the outcome of this revision process.

After many years of data collection based on gentlemen's agreement, in 2007 the Regulation 458/2007 of the European Parliament and of the Council was published in the Official Journal of the EU. The Regulation was completed by four Commission Regulations in 2007, 2008 and 2011. As a consequence the ESSPROS Manual was revised in 2008 (including the methodology of the Pension Beneficiaries module) and in 2011 (including the methodology of the Net Benefits module).

ESSPROS results are regularly published on Eurostat web site. Nowadays statistics are more and more used for evidence-based decision making processes, both in the public and the private sectors. Statistics wider in scope, of better quality and suitable for more and more specific purposes are required. The Great Recession has also brought an additional focus on social protection statistics. As a result, further developments of ESSPROS are required by users.

In 2013-2014 the dialogue between ESSPROS users and producers intensified. This growing inter-action has been very useful for producers to better understand the ever evolving user needs and for users to enhance a correct use of the available statistics. During the Working Group on Social Protection statistics held on 9-10 April 2014, possible further developments of ESSPROS were discussed: some would require a major investment (like the development of a new module), others could be obtained by a better use or via a limited modification of the existing statistical framework.
