I. Overview of Social Security Coverage in Lao. P.D.R

- Prime Minister's Decree No. 178/PM dated 30 November, 1993 on "Social Security Scheme for Civil servants"
- Prime Minister's Decree No. 207/PM dated 23 December, 1999 on "Social Security Scheme for Enterprises"
- Public Health Minister's Regulation No. dated on "Community Based Health Insurance"

1. Social Security Scheme for Civil servants

1.1 Legal Basis: PM's Decree No.178/PM dated 30 November, 1993.

Target group : Civil servants working for Party, Government, Mass Organizations, military and police.

1. Social Security Scheme for Civil servants (Cont'd)

1.2 Benefits Provided

- Health care insurance (Ceiling-based reimbursement model)
- Work Accident compensation (paid-6 month leave)
- Maternity Benefit (Paid-3 month leave) + birth grant (60% of minimum wage)
- Invalidity pension from battle field

1. Social Security Scheme for Civil servants (Cont'd)

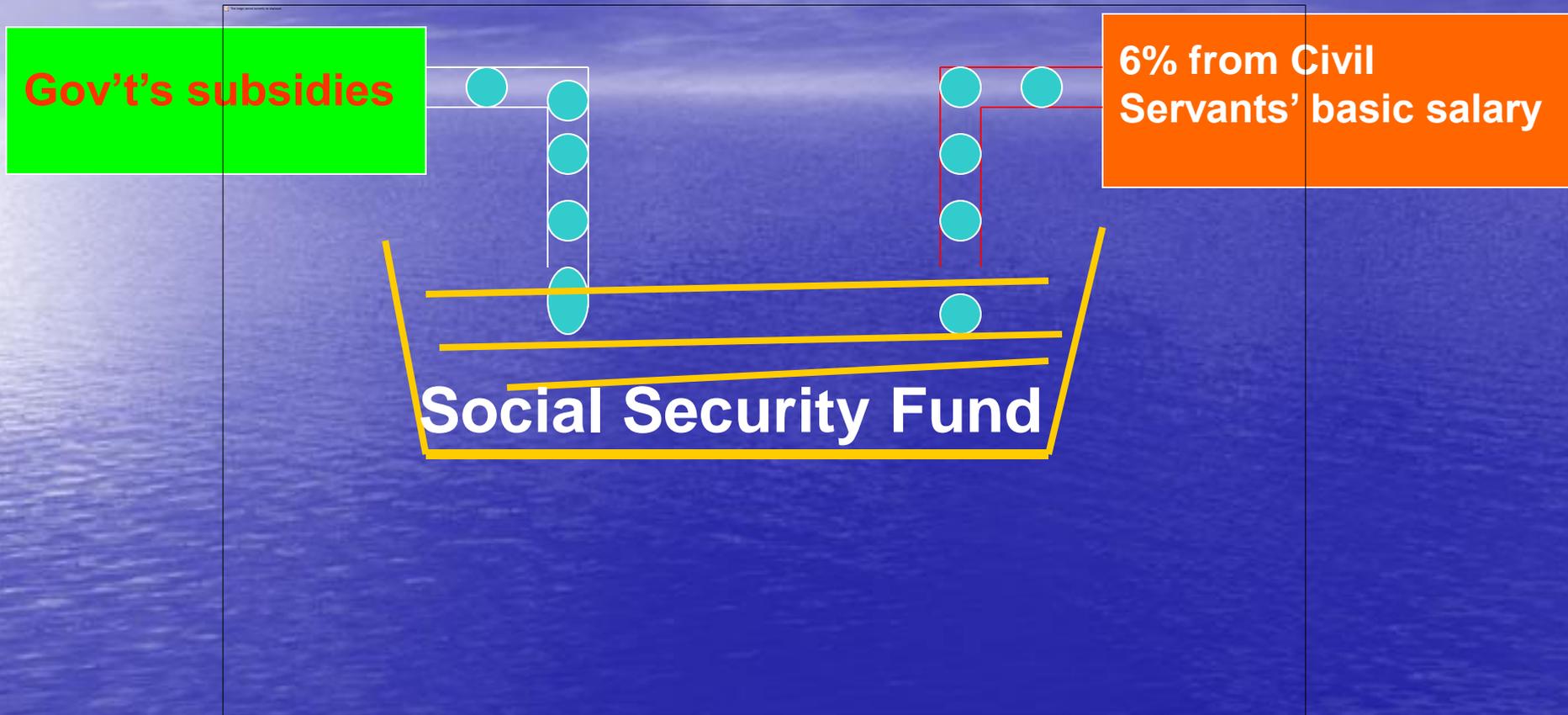
1.2 Benefits Provided (Cont'd)

- Old age pension (Male:60 y, Female:55 y)
with 25 working years
- Funeral Grant = Last monthly salary X 10
- Lump sum survivor's benefit (Depending on working years)
- Pensioners' Orphans allowances

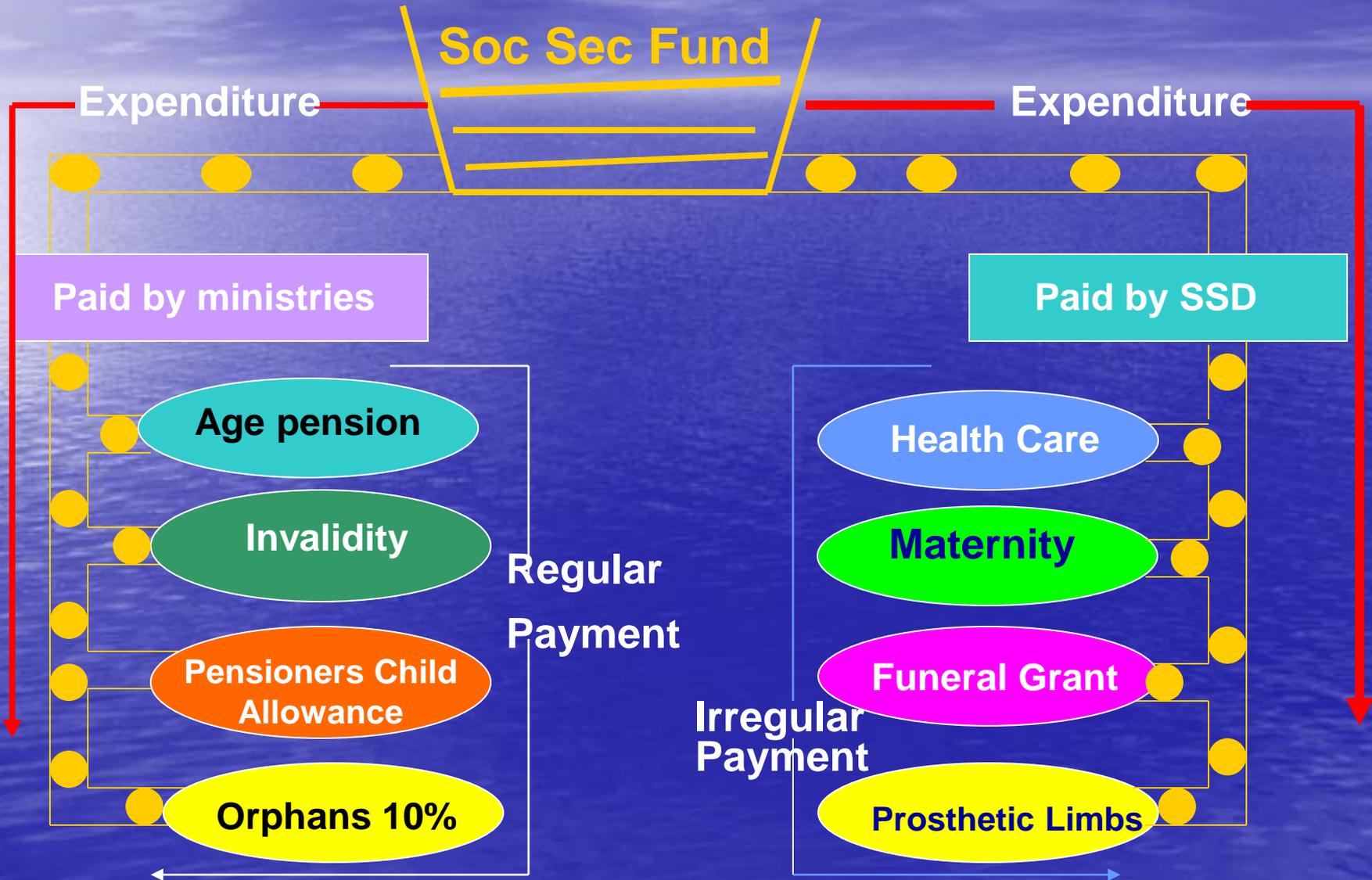

- Social Security Department (Ministry of Labor and Social Welfare)
- Budget Department (Ministry of Finance)
- Provincial Labor and Social Welfare Department
- District Labor and Social welfare Bureau

II. Social Security Scheme for Enterprises

1. Legal Basis: PM's Decree No.207/PM dated 23 December, 1999.

- *Target group* : SOE (s), Joint and privates enterprises employing 10 or more employees.

II. Social Security Scheme for Enterprises (Cont'd)

2. Implementing Agencies

- Managed by Social Security Organization (SSO)
- Tripartite Board of Directors (Supreme Body)
- Management Team
- Provincial Branches (Savannakhet; Khammouane etc)

II. Social Security Scheme for Enterprises (Cont'd)

3. Benefits provided:

(1)-Funeral Benefits

(2)-Medical Care Benefit

(3)-Sickness benefit (Temporary loss of working
capacity)

(4)-Maternity Benefit

(5)-Employment Injury &

Occupational Diseases Benefit

3. Benefits provided (Cont'd):

(6)-Invalidity Benefit (Permanent loss of working capacity)

(7)-Retirement Pension

(8)-Survivors' benefit

The following benefits shall become effective in the forthcoming years.

(10)-Unemployment Benefit

III. Social Security Scheme for Enterprises (Cont'd)

4. Contribution & Fund Allocation

PM's Decree No.207/PM

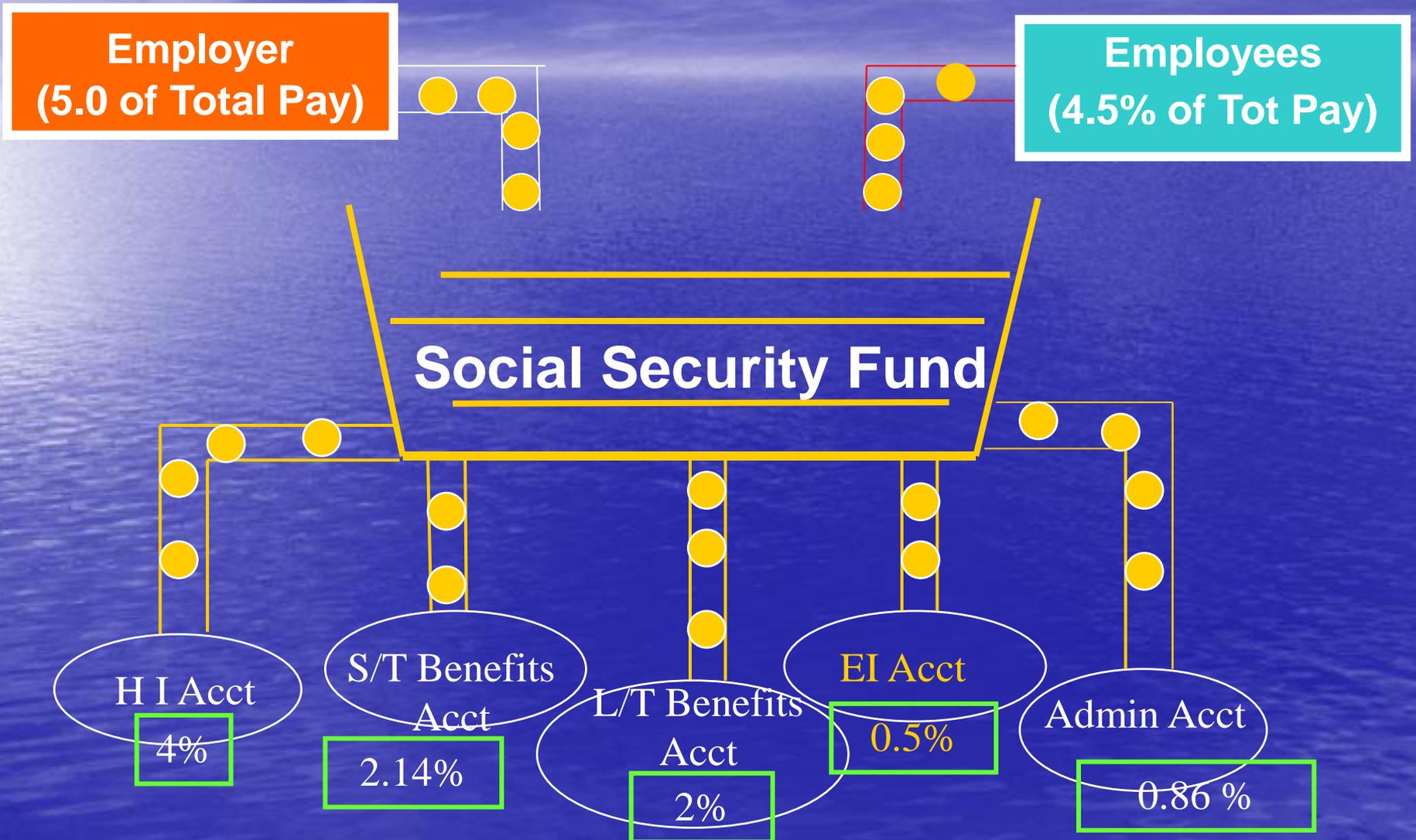
Article 17. Contributions

Contributions are paid by employers, employees and voluntarily insured persons to each fund of ***Social Security Fund.***

Article 19. Contribution to ***the Compensation Fund***

For employment injury or occupational diseases, employers ***alone shall pay*** contribution to the Compensation Fund.

4. Contribution & Fund Allocation (Cont'd)



Entitlement to each benefit

Benefits	Length of contribution payment
(1)-Medical Care benefits	\geq 3 months within the last 12 months
(2)-Sickness benefit	\geq 3 months within the last 12 months
(3)-Maternity benefit	\geq 9 months within the last 12 months
(4)-Funeral benefit	\geq 12 months within the last 18 months
<i>(5)-Employment Injury</i>	<i>No contribution period requirement</i>
(6)-Retirement Pension	At least 5 years
(7)-Survivors' benefit	At least 5 years
(8)-Invalidity Benefit	At least 5 years

 - (2)-To reform social security scheme for public sector
 - (3)-To formulate social security national plan for non-covered population
 - (4)-To formulate policy on medical treatment and compensation loss as a consequences of a motor vehicle accidents

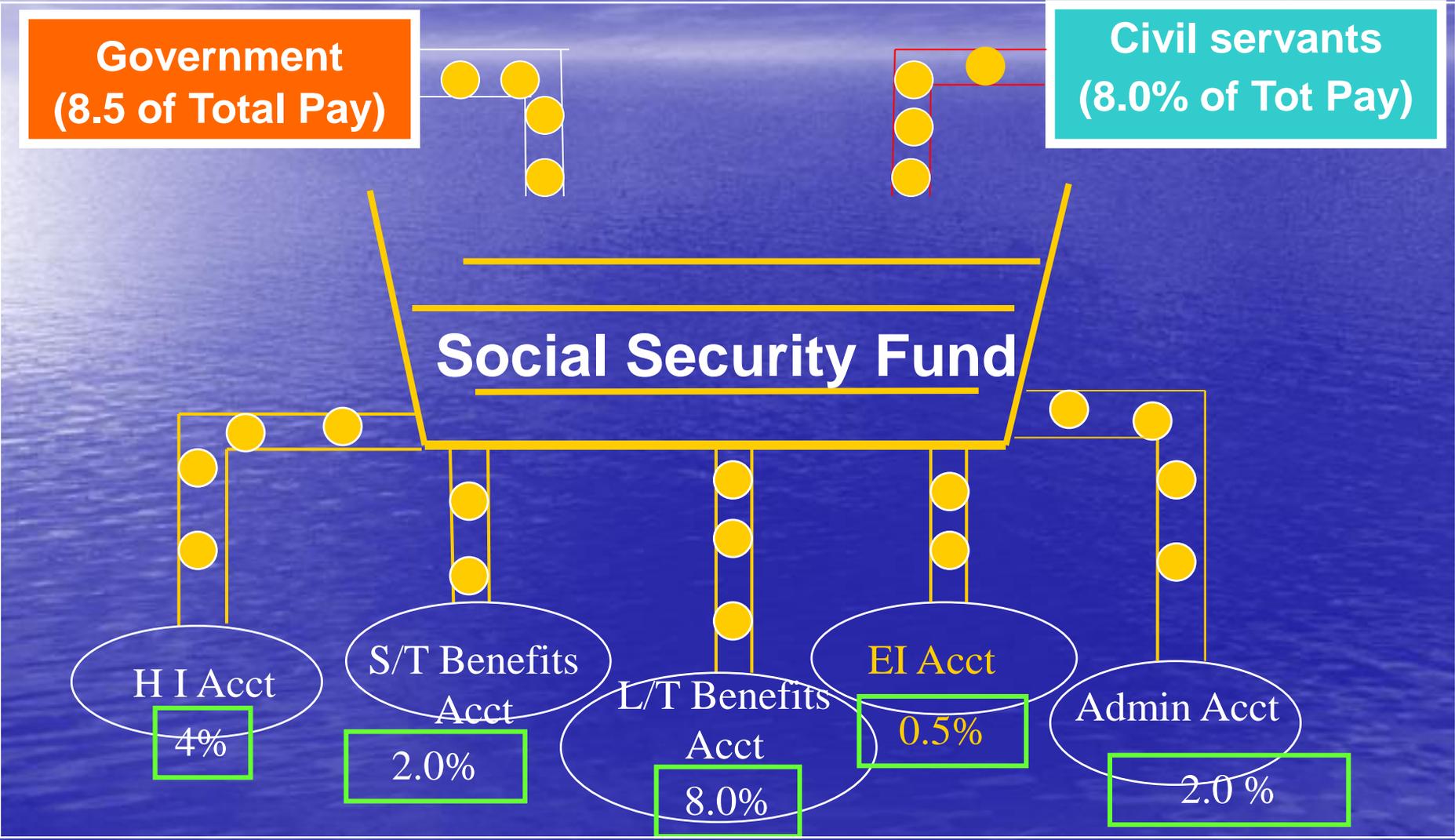

- Financial autonomous organization under the guidance of the Minister of Labor and Social welfare
