This mechanism is not only to support the sustainable implementation, but also decentralized power and empower sub-national authority for more effective work.

We are very pleased that Siem Reap province had been selected to be the first pilot area for the project implementation. We stand ready to support this work and willing to nominate relevant officers to closely work for the SSDM project in Angkor Chum and Sreisnam districts. At the same time, we will build capacity of sub-national officers to ensure the implementation of the project and 3-year Implementation Plan (IP3) of the government, and ready to expand the coverage to whole Siem Reap province and be a model for other provinces of Cambodia.

I would like to take this opportunity to express my appreciation thanks to the Council for Agricultural and Rural Development (CARD) and the International Labour Organisation (ILO) for honoring me to deliver closing remarks to this workshop, especially, I would like to thanks Excellencies, ladies and gentlemen, national and international participants from several countries such as Argentina, Brazil, Brunei, Chilly, Columbia, France, India, Indonesia, Korea, Lao, Malaysia, Mongolia, Myanmar, Nainabi, Pakistan, Philippine, Solomon, South Africa, Thailand, Vietnam, Vanutu, Zambia and other key relevant institution who have shared their opinions, experiences and knowledge for the resources for contribution to the implementation of the national social protection strategy for Cambodia as well as for ASEAN to provide social protection floors for all population especially, the poor and vulnerable.
