Stakeholder Engagement Plan (SEP) for Drafting the National Strategy for Social Protection (NSSP) in Uzbekistan

Background:

1. Social protection is at the forefront of the development agenda, given its positive social and economic impacts. It is a key element of national strategies to promote human development, political stability and inclusive growth; it ensures that people enjoy income security and have effective access to health and other social services and are empowered to take advantage of economic opportunities. By raising household incomes, such policies play a key role in boosting domestic demand, supporting structural transformation of national economies, promoting decent work, and fostering inclusive and sustainable growth. They also create a conducive environment for the development of sustainable enterprises. Social protection, therefore, is regarded as fundamental to achieving the Sustainable Development Goals (SDGs), to promoting social justice and to realizing the human right to social security for all. It contributes specifically to the achievement of SDG target 1.3 which calls on States to "implement nationally appropriate social protection systems and measures for all, including [social protection] floors, and by 2030 achieve substantial coverage of the poor and the vulnerable".

2. The UN SDG MAPS¹ mission to Uzbekistan identified social protection as one of the potential accelerators for the achievement of SDGs and suggested to strengthen its national system, including by adopting nationally defined social protection floor. It has also stressed the need to promote gender equality and address current structural barriers women are faced with in the society, as well as when accessing social protection programmes and services.

3. In September 2015, the Government of Uzbekistan (GoU) endorsed the Sustainable Development Goals (SDGs)² and in 2018 adopted its 16 national goals and 127 targets until 2030³. The GoU also established a coordination council and roadmap to achieve them. In 2019, President Shavkat Mirziyoyev convened a meeting with Ministries, Agencies and Departments (MADs) to discuss priorities in social protection covering pensions and social insurance, social assistance, employment and social care services.⁴ The President acknowledged that achieving the SDGs will, in part, depend on effective implementation of priorities in social protection to complement the GOUs comprehensive process of market-oriented reforms launched in 2017.

4. Preparation of the NSSP and its contribution to Agenda 2030 is an integral component of the Joint UN Programme Accelerating Agenda 2030 in Uzbekistan through inclusive transformation of the social protection system being implemented the ILO under the UN Joint programme. The design of the NSSP will be accompanied by costings and financing options, and fiscal space assessments⁵. Strategic priorities and recommendations for the NSSP will be based on a consultation process leading to national consensus on the priorities for social protection.

Objectives and Purpose:

5. Overall objective is to support the Ministry of Finance of Uzbekistan to design a National Strategy for Social Protection (NSSP) – with a clear and progressive vision to 2030. The strategy will bring about accelerated change in the way that social protection supports workers and families across Uzbekistan. The process necessitates systematic efforts via the Stakeholder Engagement Plan (SEP) to consult with Ministries, Agencies and Departments (MADs) with responsibilities for various policies and programmes in social protection. The objective of the SEP is to facilitate an appropriate approach for consultations and disclosure. This will, in turn, create an atmosphere of understanding that actively involves interested parties and reaches out to them in a manner that helps build mutual trust, and ensures that each MAD is provided with opportunities to voice their opinions and concerns. Overall the SEP will serve the following purposes:

- a) Stakeholder identification and analysis of policy priorities;
- b) Engagement modalities for effective communication and tools for consultation and disclosure including the mandate and modus operandi of **Thematic Working Groups** (TWGs);
- c) Enabling and identifying platforms for influencing decisions;
- d) Defining the roles and responsibilities of different MADs in the design and preparation of the NSSP.
- e) Providing opportunities for Trade Unions and Civil Society to contribute to the NSSP, and
- f) Allows international development partners to contribute to the NSSP

SEP Regulatory and Policy Framework for the NSSP:

7. The list of Ministries, Agencies, Departments (MADs) included in the SEP - at central and subnational levels - is based on two criteria:

- Budget and programme delivery responsibilities⁶
- The legal/regulatory framework of Uzbekistan's social protection system⁷

8. The SEP also provides a framework for conducting policy dialogue with Trade Unions, civil society organisations, and international development partners.

Few eligible unemployed contribute due to the widespread informality in the labour market. Furthermore, benefits are paid mostly to those without a work record or history of contribution. The decision on the assignment and payment of benefits to families with children, childcare allowance and financial assistance is made by the rural citizen's council of community, village as well as the mahalla of towns, settlements, communities and auls, or by a commission authorised by rural citizen's council to make such decisions. The allowance for families with children, childcare allowance and financial assistance are assigned to families with an average monthly total income for each family member in the amount not exceeding 1.5 times of the average amount of minimum monthly wage established in the period for which the aggregate income is calculated. The preferential right for benefits to families with children, child care allowances and financial assistance are: (a) Families who lost both parents, and the bringing up of their children is done by relatives; (b) Families where one or both parents of children are disabled; (c) Widows (widowers) raising two or more children under the age of 14, living separately from other relatives; (d) Families with a disabled child (children); (e) Mothers (fathers) raising a child (children) in a one-parent family. At the same time, the fact of raising a child by a mother (father) in a one-parent family is established by the self-governing body of citizens; (f) Families, in which one or both parents are unemployed and registered at employment support centres as job seekers; (g) Single pensioners.
