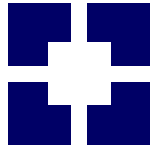


Follow-up of “EU and global health”

The EU Council adopted on June 2010 the EU Role in Global Health which

- Highlights the need to take action to
 - improve health
 - reduce inequalities
 - increase protection against global health threats.
- Emphasises the common **agreed EU values of solidarity** towards **equitable and universal coverage of quality health services** as a basis for the EU policies in this area.

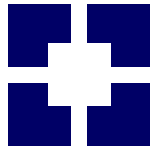




EU and MDG

- EU pledged 1 billion € for most in need countries in NY on Sept 2010
- The Treaty of Lisbon establishes the reduction and the eradication of poverty as the primary objective of the EU development cooperation policy.
- As part of global MDG efforts, the EU as a whole has committed to lift its level of development aid to 0.7% of Gross National Income (GNI) by 2015.
- At currently €49 billion per year, the EU and its Member States remain the largest global donor, but progress on reaching the threshold of 0.7% needs to be accelerated: in 2009 development aid reached 0.42% of GNI for the whole EU.



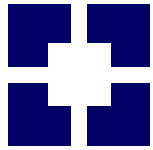


Millennium Development Goals

Progress in health development goals is fragile

- Early indications point to significant but uneven progress on the global targets for the MDGs.
- Available data and estimates suggest that
 - the global MDG target for poverty reduction - reducing by half the number of people in developing countries living in absolute poverty — will be met;
 - MDG health goals will generally NOT be met;
 - the other MDG goals, education, the environment, gender, will be in between, but with considerable variation across indicators.
 - The global economic crisis is widely presumed to have reversed progress in many countries, albeit to an as yet unknown degree.

Adoption of global action plan to achieve MDG by 2015

1. **Targeted investments in key areas**

will have a significant multiplier effect on growth and prosperity and across all the MDGs. This includes providing access to energy; job rich growth and boosting agricultural production; expanding opportunities for women and girls; and investing in health and education.

2. **The MDGs are achievable.** Every effort must now be made to accelerate progress to achieve these goals through national action plans, policies and strategies that address barriers to progress (particularly MDG 4 and 5). The UN remains a key partner in this global effort.

3. Development efforts at the national level need to be backed by an enabling **international environment that supports national actions** and strategies.

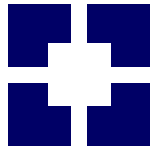

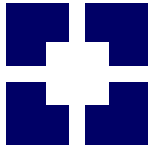


I. 7TH WORLD MUTUALIST MEETING in Latin America, Buenos Aires

and 3 fed of mutuals CAM, FAMSA, FEMU

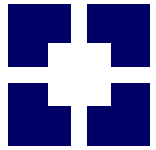


- 1200 participants from all American countries

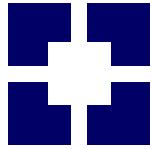

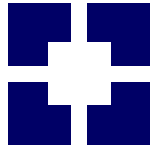
