Round table discussion on pension reforms in Indonesia

TERMS OF REFERENCE

1. Background

Old-age pension schemes has been one of the government's reform priorities. Existing schemes include Jaminan Pensiun (JP), Jaminan Hari Tua (JHT), social insurance for the armed forces and police (ASABRI), and saving and social insurance for civil servant (TASPEN), with total active participants of around 21 million or 15% of total labour force of 136 million people.

Indonesian policymakers have been discussing options for the establishment of a comprehensive old age income security system that promotes certainty, adequacy, coverage, and sustainability. Subjects of ongoing discussions include integration of JHT and severance pay into JP, obligation of civil servants, the police, and armed forces to participate in JP in addition to ASABRI and TASPEN, and establishment of a universal pension scheme.

The social protection programme of the ILO Country Office for Indonesia and Timor Leste has been supporting the government in this endeavour by providing inputs through studies and meetings. In this regard, the programme has completed two studies, namely literature review of old age income security in Indonesia and financial analysis of social security schemes in Indonesia, with focus on old age benefits.

Continuing its support in facilitating policy discussions among relevant government ministries and institutions, the social protection programme in collaboration with the Ministry of Manpower is facilitating a roundtable discussion on old age pension system reform in Indonesia.

2. Objective

This discussion aims to facilitate round table discussions between senior government officials and the ILO about the direction of pension reforms in Indonesia, with focus on its structural and systemic reforms.

The ILO will present preliminary analysis and recommendation to facilitate the round table discussions considering views of relevant ministries, government institutions, and tripartite bodies, following presentations of key ministries on their perspectives to the reforms.

3. Date & Venue

The discussion will be held on Tuesday, 20 July 2022 at 12.00-18.00 WIB in Westin Hotel, Jl. H.R. Rasuna Said Kav. C-22A, Jakarta 12940.

4. Invitees
