## 1. Introduction

Pakistan gears up for voluntary national reporting on SDGs, there is a need for coordination on various tiers, inter-organizational, inter-sectoral coordination is key to ensuring timely availability of data periodically reporting to comply for national and international commitments. The data collected will also be useful for advocacy, legal and policy reforms, resource mobilization to accelerate the progress. The social protection dashboard will be developed in close collaboration with Federal SDG unit and technical financial support of UNDP

## 2. Objective

The objective of the assignment is to develop a central database with a dashboard on social protection that will be used evidence based policy and Programme development and also to report SDG 1.3. The central database dashboard will collate and summarize data into summary tables, graphs, and design the outputs for the public as specified by federal SDG unit. The SDG unit already developed will also supplement by detailed information on SDG indicators on social protection i.e. SDG 1.3

## 3. Scope of Work

The scope of this assignment is to develop a database with dashboard on social protection that will be linked to the SDG portal for information display. The database will be developed and available at the back end to collect information from social protection agencies at provincial and federal levels. The information in the first instance will be collected through a web based questionnaire; information will be directed to the database that will be used for analysis at different tiers and for multiple uses. Key aggregate information will be displayed on the SDG portal and is also accessible to the public.

The questionnaire initially developed in word format to collect the feedback from the stakeholders. Later the web-based questionnaire will be developed based on variables of coverage and expenditure. In this assignment, it will be ensured that the national (central) database developed presents the following information:

- Coverage data: A dashboard on SDG 1.3 (indicator 1.3.1) that will show statistics on the proportion of the population covered by ongoing social protection schemes and will reveal essential information on the extent to which the population is protected against life's eventualities and how secure individuals' health and living conditions are. It is crucial to have data separately on the coverage of each contingency's social protection scheme, expressed as a proportion of the population potentially covered by that contingency.
- Information on schemes: tabulated information on schemes, their eligibility criteria, legal coverage (groups included/excluded) and other information available using existing resources (e.g. ILO's social protection mapping study);

- Expenditure on Social Protection: the information will include financial resources allocated and actual expenditures incurred for a scheme distributed by benefits received by beneficiaries and expenditure borne on implementation of the scheme (operational expenses)
- Type of Scheme/legal status: information on the type of scheme will include data on contributory or non- contributory. Whether the scheme is regulated under a legal statute or not.

## 4. Consultative Activities

### 4.1 Tool Development

Initial tool was developed by the consultant based on the SSI questionnaire shared in word format. The first version drafted and eleven questions were added related to benefits that potentially social protection schemes are providing. The benefits include pension, disability, unemployment, maternity, insurance, injury etc. The questionnaire had segregation by gender and age group.

### 4.2 Advisory Group

The first draft the Performa was shared with advisory group of international experts on social protection. The initial feedback received from the advisory such as more information is required for agency providing social protection scheme, separate out the contributory and non-contributory sections of the questionnaire, indicate that incentives are in PKR, add total column for the Male and Female bifurcation, mention vulnerable groups in the questionnaire etc. The Zoom meeting was held with consultant and advisory group on 20 August 2020. Consultant provided the overview of the toll developed and how it will be handled in the web-based application. It is explained to the participants that in the web-based format, whole questionnaire will not appear to the user to avoid confusion. Only related questions to the agency and scheme will appear for the users. However, the questions will be disabled and per users wish he/she can enable the question. Before launching of the system agency and scheme will be mapped and configured with related questions.

Various feedbacks was received during the meeting includes

- Rural/Urban bifurcation added. If the agency don't have the desegregated data then total number will be added vertical columns
- Similarly like above, a total column needed for age bifurcation for total males and females. In case agency not maintain data with age bifurcation.
- Under pension section; separate out old age, survivors and disability pension
- Rephrase the question regarding active contributors "No. of active contributors to a pension scheme". Ask number of contributors rather beneficiaries and remove the incentive and amount contributed
- There is no unemployment insurance in Pakistan

- Maternity is employer liability. Include cash benefit or other type of benefit in the questionnaire. The age group of maternity is 15-49.
- Under the work injury support, we are not looking at beneficiaries of the work injury but looking at person covered under work injury or the starting worker from 15 to 18 years. Starting age covered under work injury is 14
- Children don't receive cash benefit but parents get the cash. So question could be the number of children covered by cash benefit. There may be question to be added that the number of children receives in-kind benefit such as meals, books, uniforms, voucher, free rides to school etc. We only need to collect aggregated of all types of benefit
- The vulnerable group will added in the question and aggregated figure will be added. Below is the list of vulnerable group

- Update the age group in the section related to poverty line. It should be 0-30, 31-45, 46-65 and 65+. Also rephrase the question like "Number of persons / households covered by social assistance (UCT/cash benefits)"
- Rephrase the question like "Number of person involved in public works programmes" but is there any public works programs in country. There are none but there are WB is planning to initiate program with federal government. The parent section of this question should be "Is agency providing employment benefit". Starting age should be 15 years.
- Rephrase the question "Is agency administering health insurance scheme". Also rephrase sub-section like "Number of persons contributing to health insurance"
- There may be other subsidies such as food, housing, fuel etc. Also update the age group

### 4.3 Pre-inception meetings

#### Meeting with All stakeholders

- Meeting held with all provincial stakeholders of Punjab, Sindh, Khyber Pakhtunkhwa and Balochistan social security institutions. The draft Performa was shared with them. Consultant explained the Performa to the stakeholders. It is informed that the web-based will not be show the irrelevant section to the users and if disaggregated data is not available then total can be provided.
- Mr. Anwar from KP asked that this Performa is for ESSI or it is for overall. Rabia responded that this Performa is for all
  - Separate out all pension schemes
  - Include death grant
  - Worker welfare fund/board provides education, housing, marriage grant, scholarship. Include that in it
  - Health insurance – Simplify this section. It is difficult to provide monetary value of the medicine provided but number of persons received medical care benefit
- Mr. Babar Abbas from Punjab appreciated the Performa and commented that most of the information is very relevant. Punjab has automated system for last two years and has the information about workers and their dependents. The data available doesn't have rural and urban disaggregation
- Mr. Qabil from Balochistan told that they have the manual system. He commented to look at age group very closely. Desegregation data of Urban data is somehow available but for rural side data will be difficult as there are many remote area and many areas do not have social security coverage is not available. It is suggested to add information in total if rural and urban data is not available
- Ms. Ambreen from Sindh commented during the discussion most of things are cleared. Ease of doing business portal and NADRA will provide smart cards to workers, universalization meeting with ministers. So some questions are getting mixed in the Performa. It is explained that this performa is for all agencies and agency will information of their schemes
- It is agreed in the meeting that Consultant will develop MIS assessment form to understand type of MIS system in use by the agencies. This will be helpful for future integration with the central system. The assessment form is attached as Annex A.

#### Individual meeting with BESSI

Below is the list of inputs provided

- Rephrase the questions where there is ambiguity, such as covered persons and beneficiaries.
- Ensure that the ambiguity with relations to coverage of persons with disability and disablement pension is removed in the respective questions, as the first one is about non-contributory social assistance and the latter is the social insurance coverage under ESSIs.

- Include home based workers as a category of occupational groups that may in the future also be included under different labour legislation, this will help in preparing for the future

### **Individual meeting with KPESSI**

Some of your main concerns are as follows

- Only relevant sections of the questionnaire will be filled by the agency, those running more than one scheme will input information for each of these schemes. ESSIs will fill in information for their scheme alone highlighting two main areas; number of people covered (insured worker and dependents) and benefits being extended to them (in terms of total amount).
- As per your advice, we will add the benefit of iddat under relevant section. This may be placed under the section that speaks to schemes targeting women. (as ESSIs cover iddat for female workers in the formal sector)
- Reference to section 10.1, we will add one field on 'non-contributory health insurance scheme'. ESSIs as we understand are contributory. Here, we will also include the age brackets against beneficiaries i.e. 0-15 years and more than 15 years.

### **Individual meeting with PSPA**

Below is the list of inputs provided by PSPA

- Organize questions by life cycle stages
- Each scheme should be linked with category of social protection (social insurance, social assistance, labour market policies and programmes etc.)
- Definition of these categories may be given in the annex or foot note for understanding/consistent interpretation
- Include schemes covering skills training
- Include schemes covering LGBTQ
- Include schemes covering agri workers/occupational groups (benefits mostly include Agri inputs like fertilizers, seeds, trainings, linkages to microfinance and interest free loans)
- Under schemes for children, specific reference may be made to benefits provided to child labourers (conditional or unconditional cash transfers, school enrolment etc)
- Question 7 may also include groups like widows, destitute, orphans to expand on analysis.
- Somewhere in instructions make it clear that the questionnaire is to cover information on scheme governed by the institution/agency and NOT the employees/staff of the agency

The Performa was finalized after having consultation with the all stakeholders. The final Performa is attached as Annex-B


## **5. Proposed System Modules**

Web based reporting system will contain four modules

## 5.1 System Configuration

System configuration modules will allow system admin user

- To create and configure system infrastructure information like
  - Social protection agencies
  - Social protection schemes and association with Agencies
  - Lookups like levels (Federal, provincial)
  - Configuration of Organizational units (e.g. provinces)
- To configure population and demographics (Based on population census 2017, growth rate and demographics for denominators)
  - This also include Identification of list of denominators (See Annex C) to configure demographics
- To create and configure Users, roles and to configure access privileges of users
  - To main roles i.e., DEO, Manager
  - Users of agencies will be created as DEO and Manager roles



## 5.2 Data input System

As infrastructure is configured and users with specified roles are created, users of agencies with DEO roles are facilitated with

- Online web base input forms of
  - Social protection reporting tool which is developed with consultation and consensus (See Annex – B)
    - This online input interface will possess features of auto calculation, validation etc., for quality data input

- Since scheme are configured with sections of questionnaire therefore, agencies will see default sections enabled as configured
- Agencies can fill this online reporting tool on quarterly basis of each scheme
- Assessment Form – to assess IT capabilities (See Annex – A)
  - Online interface of assessment form are available for each agency DEO user
  - Agencies can update their IT capabilities related information using this tool

### 5.3 Development of Analytical Dashboard

Analytical Dashboard have been developed which facilitates managers role to see


- Overall calculated coverage indicator i.e., SDG 1.3.1
- Calculation of following bifurcation
  - Section wise (Sections defined in questionnaire)
  - Age group wise
  - Rural / Urban
  - Gender wise
- Trends of performance over time
- Analysis over provincial thematic map with comparison of bifurcation
- Drill down from aggregation of federal to provinces and from agencies to schemes

### 5.4 Integration with SDG Pulse portal

- Purpose of integration is to link and integrate SDG 1.3.1 indicator with SDG pulse portal dashboard
- Integration will be developed after development of analytical dashboard
- Integration are with API based using RESTful integration approach

## 6. Information flow of system

- System is role based
- System admin can configure the system
- Agencies DEO can submit reports of agencies on quarterly basis
- All information can be saved in central database
- After completion of compliance, cumulative calculation of SDG 1.3.1 indicators are integrated with SDG Pulse dashboard using RESTful APIs as show in figure
- Managers at federal level and Agencies will access analytical dashboard to see status of progress



## 7. Technology Platform

For Social protection online software, we propose Open Source technology for server-side as this is highly scalable, robust, secure, low-cost and conforms to Open standards. There is no licensing cost involved in development or deployment of the system. For client side, the user will be free to use any web browser of their choice on any operating system.

### 7.1 Server-side Technology:

- Software development in PHP v7.4, HTML 5, JQuery, CSS3, bootstrap
- Database: Postgres v11.8
- Data Exchange: XML v1.0, JSON, CSV
- Analytical Graph and Charts: HighCharts, Highmaps

- Application framework: Code ignitor

### 7.2 Client-side Technology:

- Web-browser: Any that supports CSS3, JQuery and HTML5 support: (Internet Explorer, Mozilla Firefox, Google Chrome, Safari, Opera)
- Operating System: Windows 7/8, Apple iOS, Linux

### 7.3 Web Hosting Arrangement:

- Dedicated Hosting of SDG Unit.
- Linux web-hosting with at least 1GB space (scalable depending upon database size).

- Uptime 100% with mirroring/backup arrangement.
- Data Security: Role based system, User credentials for each agency
- Protection of data loss and hardware failure through periodic backup and premium restore.

## 8. Progress on Development

### 8.1 Tool Development

Initial tool was developed by the consultant based on the SSI questionnaire shared in word format with all stake holder. After many consultative meeting during two months and on the basis of feedback from stakeholders following are the updates regarding tool development

- Reporting tool of Social protection scheme is finalized. Questions have been added related to benefits that potentially social protection schemes are providing. The benefits include pension, disability, unemployment, maternity, insurance, injury etc. The questionnaire had segregation by gender and age group. Tool is improved on the basis of feedback during consultative meetings (See Annex B – Reporting tool)
- To assess IT capabilities of each agency, assessment tool is finalized and shared with stakeholder (See Annex A – Assessment tool to assess IT capabilities of agencies)
- List of denominators have been identified for configuration of SDG 1.3.1 indicators and all its bifurcation (See Annex C – List of denominators)

Details of consultative activities have been mentioned in inception report

### 8.2 Progress on Development of Web based reporting system

Proposed system have four modules to be developed

- System Configuration
- Data input system
- Analytical Dashboard
- Integration with SDG Pulse dashboard

#### 8.2.1 Progress on Development of System Configuration module

System configuration module have been developed and available on link:

Following are the progress details of development in system configuration module

- Design and development of Login page
- Development of System admin role, authentication, system privileges configuration, authentication and session management
- Menu and front screen design
- Configuration of Agencies which includes
  - Database design

- Design in input form and interfaces
- Development of listing, insert and edit forms and submission in database
- At the moment initial data of all agencies provided have been entered in the system and system web interfaces have been tested with this data entry
- Configuration of Schemes which includes
  - Database design of schemes and association with agencies
  - Design of input forms and interfaces
  - Development of Listing, insert and edit form and submission in database
  - Association of schemes with Agencies
  - Configuration of enabled sections of reporting tools with agencies so that while submitting reports associated enabled sections of report are auto enabled by default
  - At the moment all scheme provided have been entered in database using web interfaces and scheme are associated with agencies. Moreover, questionnaire sections have been configured with schemes.
- Configuration of Lookups (Levels and Organizational Unit i.e., Provinces)
  - Interface design
  - Database design
  - Development of input forms for insert and edit
- Configuration of Population and demographics which include
  - Database design for population and demographic configuration for all denominators
  - Interface design of base population configuration at federal level and provincial level for all organizational unit – Base population is of 2017
  - Interface design of demographic configuration i.e., population growth rate and demographic ratios of gender (Male, female), Age groups, rural/urban
  - Development of Calculated report and functions of all list of denominators on the basis of base population, growth rate and demographic ratio for any year after 2017

  - This is kind of checklist to know status of IT Capabilities
  - Design of insert and edit form

Both data input form have been tested with data input of dummy reports. All login of agencies DEO have been created and now system is ready for training of agencies to start data input using online system

Analytical Dashboard are being developed and so far following reports have been developed

- Compliance report of input form submitted of schemes for each quarter
- Compliance report Agency wise with Drill down feature
- Listing Reports of Agencies and Schemes
- View of individual report
- View of Aggregated report of reporting tool
- View of IT Assessment submitted form
- Demographic report – Province wise and year wise population with bifurcation of gender, rural/urban and include field of households and growth rate
- Demographic report – province wise and age segment wise ratio to calculate denominator


### 8.4 Progress on Reporting Compliance

### 10.2 Training Videos

Training videos are an effective way to communicate information at the point-of-need and at the specific location where that information is actually needed particularly in current pandemic situation around the globe. ## 11. Capacity Building Session

### 11.1 Objective

Training objective is to train all focal persons of the social protection agencies to configure their schemes, assign the relevant questions, report data on their respective schemes that agency is offering.

### 11.2 Training Activities for Social Protection Agencies

As described in section user manual and training video has been developed to aid focal persons of social protection agencies to use the system. In addition, Pace Technologies provided trainings to all focal persons of the agencies. The two sessions through Zoom technologies were conducted to by our experts. The training was focused on

1. Accessing the system using valid credentials and URL

The participants were trained on

- a. Accessing URL - <http://sp.sdgpakistan.pk>
  - b. Provided login credentials – Provided hands-on practice to enter into the system with valid credentials. Rectified problems, if the user was not able to login
2. Landing page of the system
    - a. Once the users were able to login then they were able to see the landing page of the system. It was oriented to them that this landing page will help them to see the number of reports entered by that agency along with the information of reporting period. The user can view edit or delete the report.
    - b. Also landing page gives them an option to add new report

3. Data entry of the respective schemes
  - a. The participants were oriented on the data entry of their respective schemes. It was oriented that how data will be entered. There are data desegregations of data are available in the data entry form. So, there is a possibility that agency may not have desegregated data of the scheme. Therefore, it is oriented that aggregated data can also be entered.
  - b. The frequency of the data entry is quarterly. Each agency will enter a report of its respective schemes in each quarter
  - c. Training was also provided for the questionnaire to assess the IT capacity of the reporting agency. This is one-time activity for every agency to report into the system
4. Manager's View
  - a. The training was also focused to for managers supervising the data entry or utilizing the data
  - b. It was oriented that with manager's view, the user can monitor the data entry status of its respective schemes
  - c. Managers can also view the configurations of the schemes
5. Configuration of the schemes

Configuring schemes was also important session of the training.

  - a. In this session, users were trained on configuring the schemes. While configuring the scheme; the agency name is read only and from the drop-down user can scheme type, provide title of scheme, description of scheme, and can select other information related to schemes from drop down menus.
  - b. There are thirteen sections of the questionnaire. User was trained to select appropriate sections related to the schemes.
  - c. Once the schemes will be configured then questionnaire will be available for quarterly data entry of the scheme
6. Access reports and dashboard

The users were trained on using analytical reports and dashboard

### 11.3 SDG Unit Training

In order to sustain the National Database on SDG 1.3.1 (Social Protection), the ownership of the system by Federal and Provincial SDG units are essential. The essential staff of the SDG unit needs to be trained on the system administration, data entry and monitoring of the data reported in the system. A separate session was planned with the federal and provincial SDG unit. In this training the participants were trained on the system administration by accessing admin portal <http://sp.sdgpakistan.pk/admin/login> URL.

### 11.3.1 System configuration

1. Landing page will show the number of agencies registered in the system
  - a. User were trained to create add new agency of national or provincial levels
  - b. User were trained view, edit and delete the agency already in the system
2. Schemes/Program – User having admin privileges can view all schemes configured in the National Database on SDG 1.3.1 (Social Protection). Admin user cannot edit the schemes.
3. Scheme Types
  - a. Users were trained on adding scheme types and;
  - b. Edit, view or delete the existing user types
4. Level – two levels already added and system admin cannot add/delete levels. These were program decisions
5. User Management
  - a. Participant were trained to create users
  - b. System admin can create users of a particular agency
  - c. While creating users, system admin will assign agency, user level (National or provincial), user type (Manager or Data Entry operator) and other profile information of the user such as Name, designation, email, contact number and assign a username.
  - d. Participants were also trained on edit, view and delete users
6. Provinces – Information about provinces and regions are already filled in the system. System admin cannot add, edit or delete the provinces and regions information

### 11.3.2 Demographics

The demographics menu has two options

1. Province wise population

The participants were trained on the above menu items. The system administrator can add/update the population of house hold with disaggregation of Male, Female, transgender. Also population can be added by province with disaggregation of rural and urban.

2. Province wise age ratio

The participants were trained to update the province wise age population. The user can add age ratios by age group and by province

## 11.4 Reporting

### 11.4.1 Compliance

All participants were trained to view the quarterly reporting compliance of its respective agency. It was oriented that user can view the reporting compliance depending on the role of user. If a user has a role of national level and scheme of its agency is providing social protection services

in provinces then the national user would be able to see the reporting compliance of all associated schemes at provincial levels. While provincial level can see the reporting compliance of its schemes operating in provinces. The compliance report will help managers to view the status of data entry. A screenshot describes the reporting and non-reporting status of scheme data. In the screenshot cross in red color represents non reporting and tick in green color represents reported data.
