Unemployment protection in Indonesia: Quality assistance for workers affected by labour adjustments

Overall

The project aims to strengthen support mechanisms for the unemployed by designing an employment insurance scheme, expanding re-skilling training and improving public employment services.

Outcome

Affected workers by labour adjustment are systematically supported by a temporary income replacement, re-skilling training and employment placement services.

24 months (1 August 2019 – 31 July 2022)

Overall

The project is designed to continue to support our current technical works to support comprehensive social protection reforms (Extension to workers in the informal economy, unemployment, maternity and sickness benefits)

More workers are covered by social security schemes, through gender sensitive and rights based improved policy and legal frameworks, and enforcement and delivery mechanisms in Indonesia
