



THE MINIMUM REQUIREMENT IS 24 MONTHS



LAST 9 CONSECUTIVE MONTHS PRIOR



12 MONTHS OF WHICH THE LAST 3 CONSECUTIVE MONTHS

# SOCIAL INSURANCE PREMIUMS MONTHLY

Type of social insurance	Rate of premium to be paid from the employer's salary fund and equivalent income /percentage/	Rate of premiums to be paid from the salary and equivalent income of the insured /percentage/
1.Pension insurance	8.5	8.5
2.Benefit insurance	1.0	0.8

<b>4.Unemployment insurance</b>	<b>0.5</b>	<b>0.2</b>
Premium amount	10.5, 11.5, 12.5	9.5



# EMPLOYEES IN THE PUBLIC SECTOR

Mongolian citizens, foreigners, stateless persons, and civil servants, unless otherwise specified by law, shall be compulsorily insured.

	<b>Payment period of unemployment insurance benefits /by month/</b>	<b>The rate to be calculated the benefits /by percentage/</b>
<b>1.</b>	24-59	50
<b>2.</b>	60-119	55
<b>3.</b>	120-179	60
<b>4.</b>	180 or more	70

Unemployment benefits will be paid until the end of 76 working days.  
If you get a job while receiving unemployment benefits, the social insurance institution will be notified and benefits will be stopped.

## The following benefits and discounts shall be issued by unemployment insurance fund:



- ❖ unemployment benefits
- ❖ premium discount


## The following benefits and premiums payments shall be issued by benefit insurance fund:



- ❖ of the temporary loss of employability
- ❖ of the pregnancy, or giving a birth to a child
- ❖ of issuing to the family member of the deceased insured
- ❖ payment of the premiums of the pensions and benefits insurance to the voluntarily insured mothers who take care of children under the age of three

# THE ISSUANCE OF THE UNEMPLOYMENT BENEFITS SHALL BE TERMINATED UNDER THE FOLLOWING GROUNDS:

- got a job during the period of receiving unemployment benefits, and started to pay a mandatory premium;
- established pensions on old age and/or the loss of employability;
- it was found that receipt of the unemployment pension was unjustifiable;
- called up for physical military service;
- a court decision on serving a prison sentence has entered into force;
- passed away during the period of receiving unemployment benefits.
