

## **Social Protection, Freedom and Justice for Workers Network**

2nd Webinar – 23 October 2018, 14:00 – 17:15 (Geneva time)

### **Context**

The Social Protection, Freedom and Justice for Workers Network was initiated in 2017 by the ILO in cooperation with the International Trade Union Confederation (ITUC) and involving members of the Global Coalition for Social Protection Floors. As one of the strategic partnerships of the [ILO's Global Flagship Programme on Building Social Protection Floors for All](#), the network was created to support workers' organizations in the promotion and defence of the right to social protection.

Through capacity-building, awareness raising and knowledge-sharing, the network intends to strengthen the capacities of workers to defend social protection, meaningfully participate in national dialogues on social protection. Workers' organizations have a decisive role to play in the various dimensions of social protection in the effort to achieve SDG 1.3 on social protection systems and floors in line with relevant ILO standards. Trade unions are also key to safeguard acquired rights that are threatened by inadequate short-term adjustment measures and social security reforms.

On 24 October 2017 the network had its first meeting to consult workers' organizations from across the globe on the need for a network of this nature, and to define its objectives according to the priorities of workers. In the past year, an [online knowledge-sharing platform \(http://workers.social-protection.org\)](http://workers.social-protection.org) was created to facilitate the access of workers' organizations to relevant materials and tools on education, advocacy and accountability in the field of social protection to equip workers with technical and policy arguments for advancing rights-based social protection.

This web-based discussion will offer an opportunity to share information on the network, exchange experiences, and discuss topics of relevance for the labour movement in the field of social protection.

### **Objectives**

- To strategize how to advance social protection in times of austerity;
- To discuss progress made towards the achievement of universal social protection and the promotion of the Social Security (Minimum Standards) Convention, 1952 (No. 102) and the Social Protection Floors Recommendation, 2012 (No. 202), with a special focus on gender issues and on the extension of social protection to workers in the informal economy;
- To take stock of recent ITUC, trade unions', and ILO activities in the field of social protection;
- To share information on developments of the Workers Network and discuss how the network can best serve the needs of workers organizations.
