**UP-TO-DATE¹ ILO SOCIAL SECURITY STANDARDS
AND THEIR STATUS OF RATIFICATIONS**

1. Social Security (Minimum Standards) Convention, 1952 (No. 102)

Description: Defines the nine branches in social security (medical care, sickness benefit, unemployment benefit, old-age benefit, employment injury benefit, family benefit, maternity benefit, invalidity benefit, survivors' benefit) and sets minimum standards for these benefits concerning scope of coverage, kind of benefits, their duration and their qualifying conditions.


Ratifications: 42

2. Invalidity, Old-Age and Survivors' Benefits Convention, 1967 (No. 128)


Description: Higher Standards than Convention No. 102 with regard to invalidity, old-age and survivors' benefits

Ratifications: 16

Africa: Libyan Arab Jamahiriya (1975).

Americas: Barbados (1972), Bolivia (1977), Ecuador (1978), Uruguay (1973), Bolivarian Republic of Venezuela (1983).

Europe: Austria (1969), Cyprus (1969), Czech Republic (1993), Finland (1976), Germany (1971), Netherlands (1969), Norway (1968), Slovakia (1993), Sweden (1968), and Switzerland (1977).



Prospective ratifications: Not known.

Related instrument: Invalidity, Old-Age and Survivors' Benefits Recommendation, 1967 (No. 131).


3. Employment Promotion and protection against Unemployment Convention, 1988 (No. 168)

Description: Provision for benefit or allowances to the voluntarily unemployed.

Ratifications: 7

Americas: Brazil (1993).

Europe: Albania (2006), Finland (1990), Norway (1990), Romania (1992), Sweden (1990), Switzerland (1990).



Prospective ratifications: Not known.

Related instrument: Employment Promotion and Protection against Unemployment Recommendation, 1988 (No. 176).
