CAN INDONESIA INTRODUCE AN EMPLOYMENT INSURANCE SYSTEM?

YES, BUT THERE ARE DECISION POINTS

Yes, because Indonesia has:

- Finance: Employment insurance is not an expensive scheme
- Institution: BPJS Employment has similar operational flows through JKK
- ALMPs: Vocational training and some employment services exist

But, Indonesia needs to decide how to:


- Reform or keep statutory severance pay
- Harmonise EI with JHT, JP, JKK and JKm
- Coordinate unemployment benefits and ALMPs within the government
- Consult among tripartite stakeholders

INSTITUTIONAL SET-UP IN OTHER COUNTRIES


JAPAN

MHLW administers the entire system through its local bureaus. Hello Work is responsible for claim, contribution collection, payment and all other employment services.



KOREA


MEL administers the entire system through Employment Security Office (claim and payment) and COMWEL (registration and contribution collection). COMWEL reports to MEL, and share data with EOS.



INSTITUTIONAL SET-UP IN OTHER COUNTRIES


THAILAND

Department of Employment regulates, and Social Security Office deals with claim, contribution collection and payments. DOE's Employment Service Office coordinates PES with Department of Skills Development.



VIET NAM

Employment Service Centres receive claims and calculate benefits; DOLISA approves them; and VSS collect contributions and make payments.
