Introduction

The Social Security Inquiry (SSI) questionnaire has become the main comprehensive tool used to compile data on social protection coverage for children, unemployed persons, older persons, persons with disabilities, pregnant women, newborns, work-injury victims, and the poor and vulnerable. In addition, indicators on adequacy of social protection benefits and the revenue and expenditure of the social protection schemes are produced based on the data provided in the questionnaire. The ILO Social Protection Department has been disseminating comparable statistics on global social protection programs periodically via thematic studies as well as the [ILO Flagship World Social Protection Report](#), which is published triennially and includes information on legal and effective coverage of social protection systems, descriptions of contributory and non-contributory programmes, indicators of adequacy of benefits, social protection expenditure and others for more than 190 countries.

This **“Getting Started”** manual is designed to help users navigate the technical aspects of SSI tool and to act as a guide through the main questionnaire features.

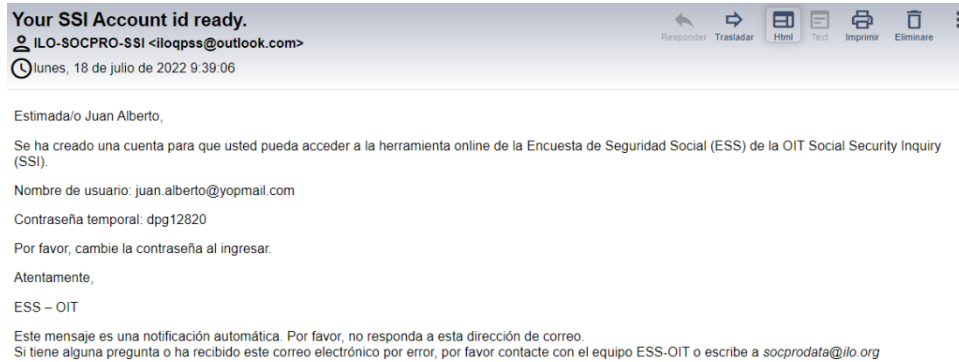

Setting Up

Contact the system administrator to have your account set up. You will receive an automated email from the QPSS system when your account has been created. The email will contain a temporary password you can use to log into the QPSS system.

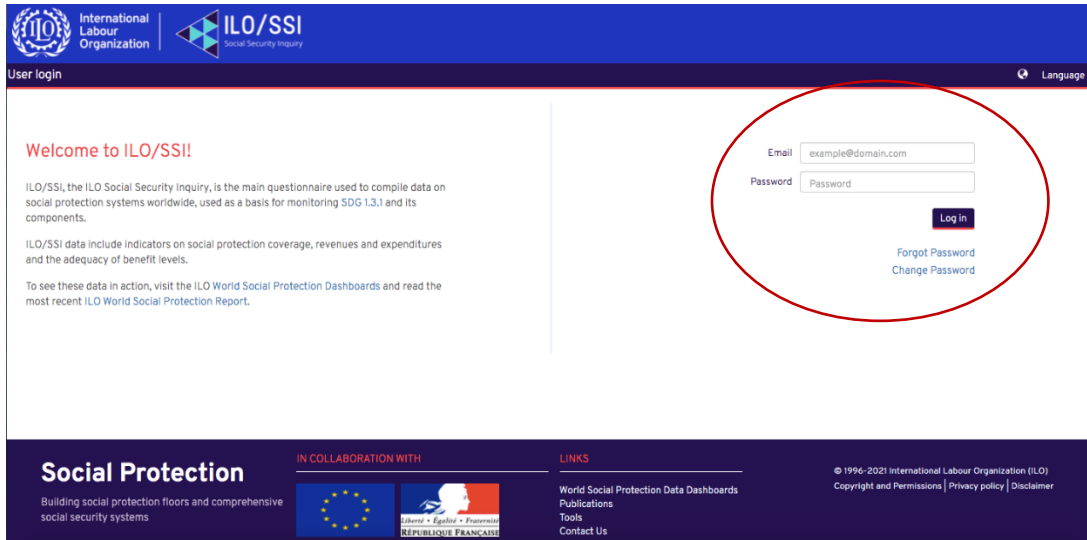
If you do not receive an email from the ILO/SSI system, please check your spam folder. The email should come from the following email address: iloqpss@outlook.com



Go to qpss.ilo.org and click on the ILO/SSI Social Security Inquiry button with the light blue and dark blue triangle.



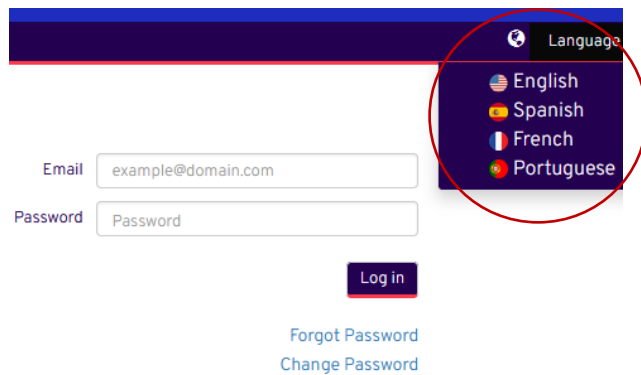
Enter your email and the temporary password included in the automated email you received from the system administrator. You will be asked to enter your existing password (the temporary one you received in an email) as well as a new password. Please note that your new password must be at least eight characters. Write down the new password for future use to avoid having login issues.



When entering the temporary password and the new password, please make sure you do not add an extra space at the end and type the password slowly to avoid typos. After establishing your new password, you will be able to log in with your new credentials.

If you forget your password, you can click on the Forget Password link to set a new one. If you'd like to change your password, click on the Change Password link and follow the prompts.

You can change the system interface language by using the Language button in the top right-hand corner. Currently the interface is available in English, French, Portuguese and Spanish.



Page Roles and Functionalities

When the system administrator creates an account for you, your account will be one of four types:

- General user (GU)
- Country responsible (CR)
- Administrator
- Global administrator (GA)

General user (GU)

GUs are able to fill in a survey once they've been granted access to the platform. Only users with Global administrator profiles can create GU accounts but all other profiles can invite someone to edit a survey as GU. When created, GUs will receive an email confirming their account has been created, asking them to log in with a temporary password and later change their password for future log ins.

GUs may also be invited to fill in a survey as well, without needing to have an account on the platform. When invited, the GUs' access is share-link based so they can always access and edit a survey using the link they've been provided.

GUs will only be able to see the survey management tab and open the surveys you have been assigned to, as shown below.

Country responsible (CR)

CRs are profiles that are linked to one or several countries. Individuals with this type of account usually coordinate the data collection for the survey in a specific country.

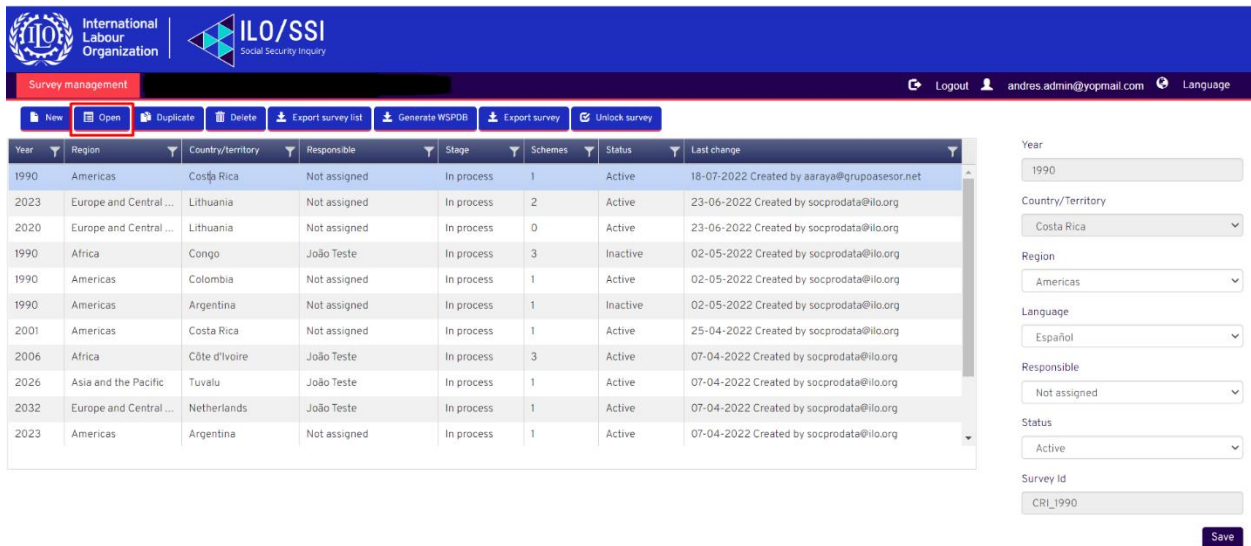
CR will only be able to see the survey management tab and open the surveys you have been assigned to, as shown below.



Administrator

Administrators have access to the Survey management tab but not the User management tab. Therefore, while they can access all surveys, they cannot create or modify users.

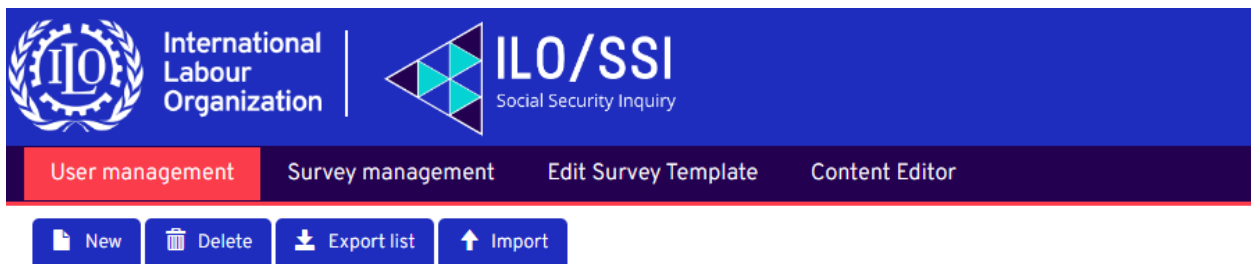
To begin editing a survey, simply find the country name from the survey list, select it by clicking on it and choose open.



Global administrator (GA)

User management

GAs can create users with a unique email, country and role, and also have access to two interfaces: user management and survey management, as shown below.



In the User management tab, the GA can create additional users. Users can be made active or inactive. A person will be notified by email when their profile has been activated.



Survey management

In the Survey management tab, the GA can look through a survey and also generate data for the World Social Protection Database.

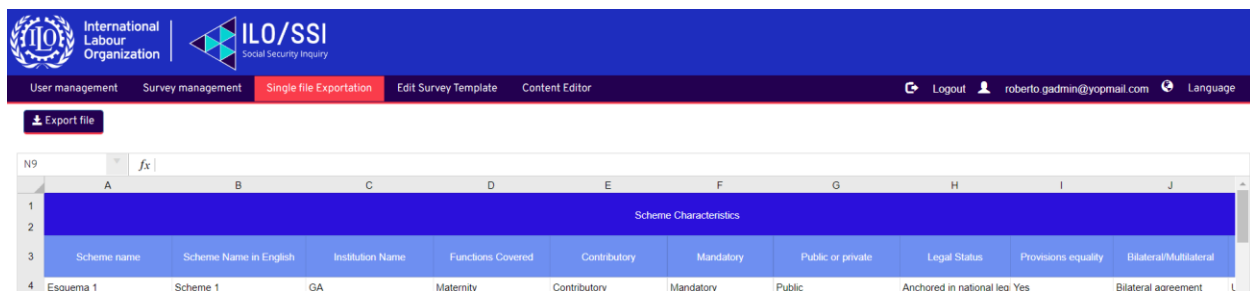
Please note it is impossible to create two surveys for the same country for the same year. When creating a survey, the administrator can choose the language the survey will be displayed in (currently only either English, French or Spanish).

All users will also see an Export survey list button and an Export survey button. Clicking the Export survey list button will download a list of all of the surveys currently recorded in the SSI system (in .xlsx format).

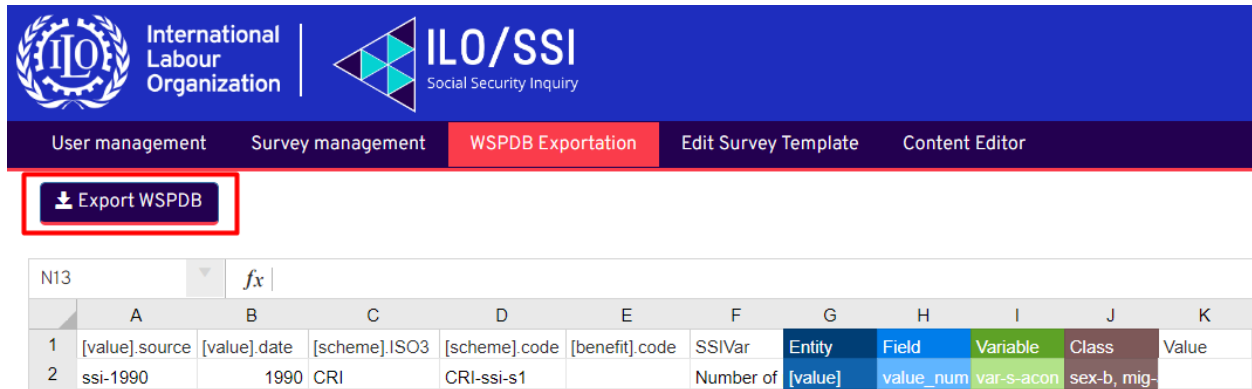
The Export survey button will prompt you to choose a country survey to download in Excel format. Before you can download the survey, you will be taken to a new page where you can visualize the data for that survey. Click the Export file button to complete the download.

The Import button will allow you to import the scheme and benefits data from the selected survey. Note that to import you must use the template that is displayed when exporting a survey using the "Export Survey" button.

Surveys can be created for both migrants and non-migrants. The change between one and the other is that in the Schemes-No Migrants spreadsheets some rows of data will not be displayed.



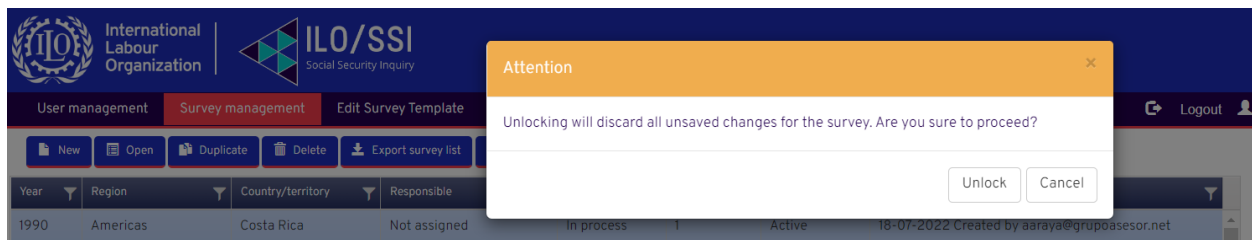
Generate WSPDB: after clicking the generate WSPDB button, the system will make you choose the country survey you want to download in Excel (.xlsx) format. Before you can download it, it will take you to a page where you can view the survey data. Click Export WSPDB to download.

Unlock survey: through this option, the GA can release the editing locks associated with a survey by other users.

Edit survey template

In the survey template tab, the GA can edit the texts, colours, fonts for the different templates used in the survey. When manipulating the templates, be careful not to add or remove rows or columns to the templates.

To edit a template, you must first choose the section you want to edit.

Then you can edit the template and finally you can click on the save button.

Content editor

In the content editor tab, the GA can edit the content displayed on the instruction pages and the login page. To modify the content of a page, you must first select the page to edit, then the system displays the content of the selected page in editing mode.

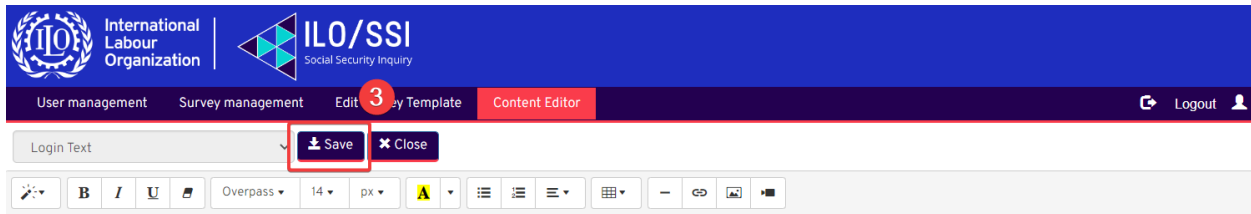

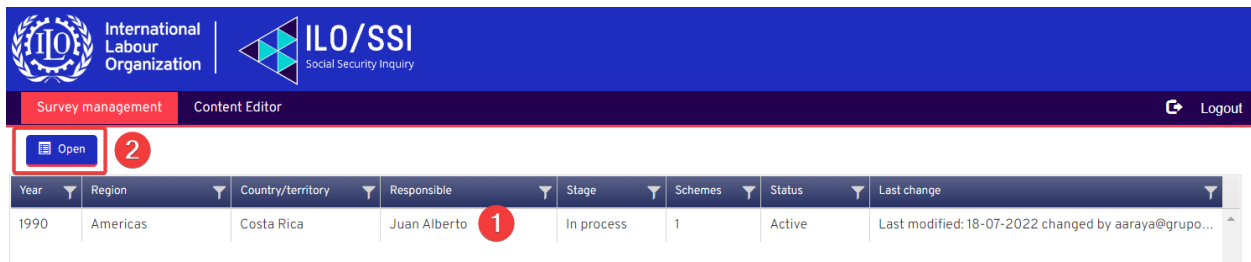

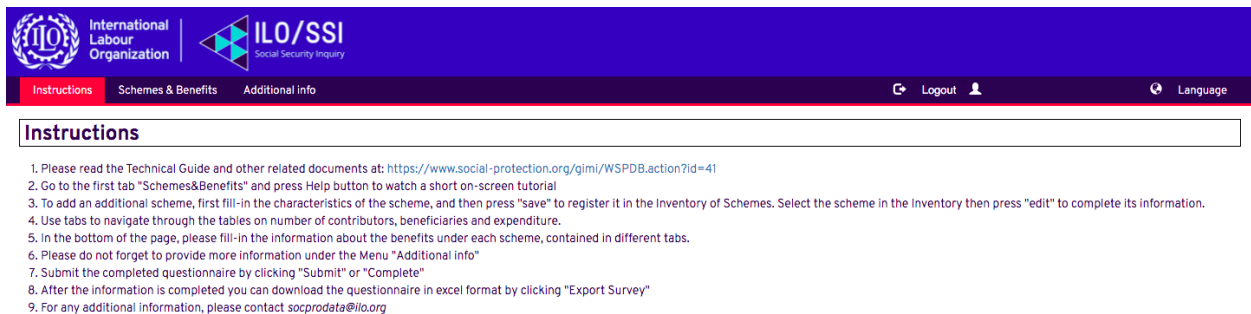
ILO/SSI, the ILO Social Security Inquiry, is the main questionnaire used to compile data on social protection systems worldwide, used as a basis for monitoring SDG 1.3.1 and its components. ILO/SSI data include indicators on social protection coverage, revenues and expenditures and the adequacy of benefit levels. Survey Overview

When you log in to the platform, the system displays the survey management module, where you need to choose the survey, you want to complete, select the survey from the list, and then click open.



When entering a survey, the system takes you to the tab containing the Instructions, which is part of the main menu. In this tab you will find a summary of how to fill out the survey, definitions of essential words and concepts, and a chart that summarizes how the programs and benefits are categorized. You can return to these instructions at any time for further clarification by clicking on the “Instructions” tab.



Concepts and definitions

Social protection programme/scheme (or social security programme/scheme). Distinct framework of rules to provide social protection benefits to entitled beneficiaries. Such rules would specify the geographical and personal scope of the programme (target group), entitlement conditions, the type of benefits, benefit amounts (cash transfers), periodicity and other benefit characteristics, as well as the financing (contributions, general taxation, other sources), governance and administration of the programme. Social protection programme provides protection against a single or several risks or needs, and covers a single or several specific groups of beneficiaries.

Contributory scheme. Scheme in which contributions made by protected persons directly determine entitlement to benefits (acquired rights).

Non-contributory schemes, including non-means-tested and means-tested schemes, normally require no direct contribution from beneficiaries or their employers as a condition of entitlement to receive relevant benefits. They include, for example, social pensions, CCT, school feeding programs, etc.

Universal scheme/categorical scheme (applied to non-contributory) provides benefits under the single condition of residence. However, the term is also often used to describe categorical schemes that provide benefits to certain broad categories of the population without a means test or proxy means test. The most frequent forms of such schemes are those that transfer income to older persons above a certain age, to all persons with disabilities, or to children below a certain age.

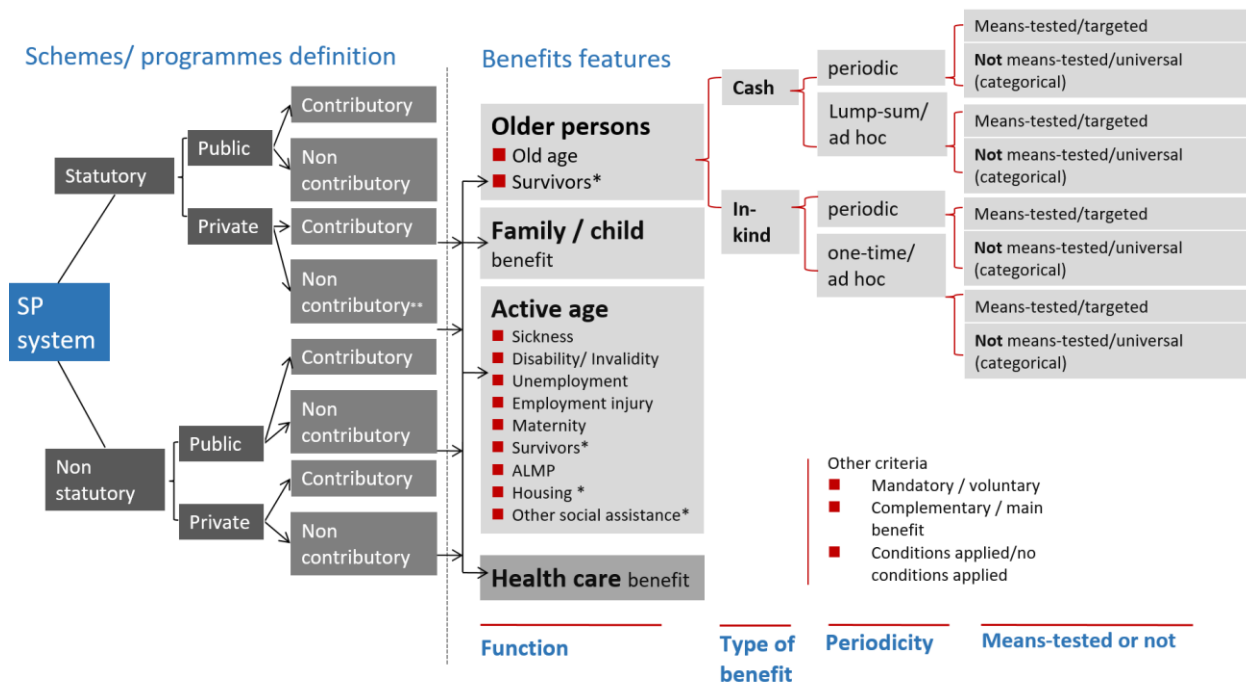
Targeted / Means-tested / Social assistance scheme/programme (applied to non-contributory). A scheme that provides benefits to vulnerable groups of the population, especially households living in poverty. For instance, most of social assistance CCT schemes are means-tested. A scheme provides benefits upon proof of need and targets certain categories of persons or households whose means fall below a certain threshold, often referred to as social assistance schemes.

Conditionalities. Cash transfer programmes that provide cash to families subject to the condition that they fulfil specific behavioural requirements are referred to as conditional cash transfer programmes (CCTs). This may mean, for example, that beneficiaries must ensure their children attend school regularly, or that they utilize basic preventative nutrition and health-care services.

International Labour Migration, is a generic term used to capture the movement of international migrant workers, for-work international migrants and return migrant workers (ILO, 2018. Guidelines concerning the statistics of intentional labour migration. 20th International Conference of Labour Statisticians, Geneva).

International Migrants, include residence in a given country that have ever changed their country of residence or "All persons who are usual residents of that country and who are citizens of another country or whose place of birth is located in another country" (ILO, 2018. Guidelines concerning the statistics of intentional labour migration. 20th International Conference of Labour Statisticians, Geneva).

Diagnostic: Categorisation of schemes & benefits



* means that this function can concern several age groups. It is allocated in the group considered as the main group concerned.

** donor-funded programmes anchored in legislation

The above image, which sits at the bottom of the Instructions tab, provides a summary of the categorisation of schemes and benefits in a country. A country’s social protection system can be either statutory or non-statutory, meaning anchored in national legislation or not. A scheme can be of public or private administration and either contributory or non-contributory. Schemes and benefits can cover one or several social protection funds and the payment of the benefit can be either in cash or in kind. For any benefit, the periodicity can be regular or lump-sum/ad hoc. Finally, a benefit could be universal, means tested or benefit tested (as detailed in the Concepts and definition section of the Instructions page).

You’ll notice there are two further tabs in the main menu bar: Schemes & Benefits and Additional Info.

The Schemes & Benefits tab is divided into three main parts: (a) an Inventory of Schemes on the top left-hand side, (b) a section where you can enter Scheme Information on the top right-hand side, and (c) a section below both where you can enter information on the Benefits under the scheme. Please note you will have to scroll down to view the Benefits under the scheme section.

Your email will appear in the top right-hand area of the main menu bar. Your country flag, country name and the year that corresponds to the survey will appear in the top right-hand corner of the page above the Language settings.

Filling in the Schemes & Benefits section

The Schemes & Benefits section of the ILO/SSI consists of three main parts:

- Inventory of Schemes
- Scheme information
- Benefits under the scheme

We will discuss each section in detail below.

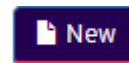
Inventory of Schemes

The Inventory of Schemes is a master list of all of the major schemes that exist in a country and serve to provide an overview of the social security system.

Some of the schemes in the inventory may be pre-filled based on information previously submitted to the ILO. – **PLEASE CAREFULLY CHECK FOR MISSING SCHEMES OR MISSING INFORMATION. LIKEWISE, PLEASE REMOVE OUTDATED INFORMATION ON SCHEMES THAT NO LONGER EXIST.** To remove a scheme from the Inventory of Schemes list, click on that



scheme and then on the Delete button.



To add a new scheme, simply click the blue New button on the left.

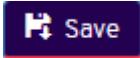

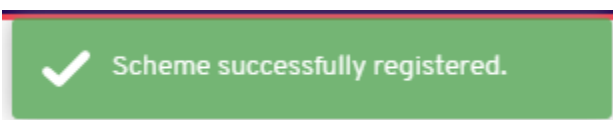

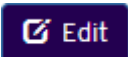

The survey is composed of a series of Excel-like tables where you will be asked to choose your response from a dropdown list or to input your country’s data. Please note that, as when you work in Excel, you may adjust the height and width of the table’s cells. However, the adjustments can only be carried out manually, by dragging and dropping the cell’s edges to expand or reduce its size. In some instances, the cell size will automatically be made to fit the text but not in all instances.

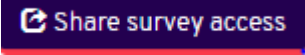
Remember to click the Save button  frequently to avoid losing any of your work. When you click the Save button, you should see a green pop-up in the top right-hand corner of your screen that reads Scheme successfully registered, confirming that your information has been saved.

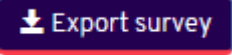



After you click Save, the information entered will be “locked” and in order to make any further changes, you will have to click the Edit button . Please note that depending on the size of your screen, the Edit and Save buttons may appear on the same line as the other buttons, or just below. You may begin editing when you see red text appear beneath the Scheme information section of the page that reads, ‘Scheme locked by [Your Name]’.

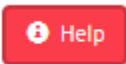
Scheme Information

Scheme locked

The Share survey access button  allows you to share the survey with someone else for editing. After clicking here, you'll be asked to enter the email of the person who you'd like to grant access to the survey. This person will then be able to edit the survey.

The Export survey button  will generate an Excel version of the information entered into the survey.

The green Reviewed button  shows that the survey has been reviewed by ILO's SOCPRO data team.

For a quick overview of the parts of the survey, click on the red Help button  and a series of pop-ups will lead you through the survey. If you require further assistance, write to use at socprodata@ilo.org.

Save and log out when you are done filling the survey or if you know will be away from your computer for an extended period of time. If you do not log out, when and come back to fill in the survey, the system may log you out and display an error message like the one below.

When this error comes up, simply go to qps.ilo.org and click on the ILO/SSI Social Security Inquiry button to access the survey again. If you are still unable to access the platform, try using a different browser or clearing your browsing data.

We recommend you view the platform in full screen so all of the various parts of the page appear as below, or as close as possible to how it is shown in the guide.

Scheme Information

The Scheme Information section aims to capture scheme-specific information, including the scheme’s characteristics (who administers it, whether it is contributory, etc.), the number of contributors, if contributory, the number of beneficiaries, and data on revenue and expenditure for the scheme.

Please note that the system will not allow you to navigate from the first tab in the Scheme information section (Characteristics) to the subsequent tabs (Contributors, Beneficiaries, and Revenue and expenditure) until the information in first tab has been filled. Please work in order and fill in as much information as possible.

You can also click on an existing scheme from the list and edit the details for that scheme. Remember to click the Save button frequently to avoid losing any of your work, should you have internet connectivity issues or leave the computer idle for some time.

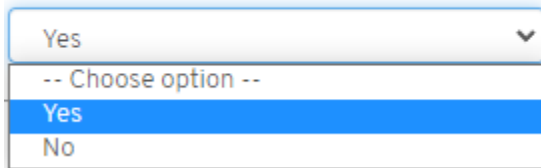
