- Indonesia is ranked at high level of risk of climate-related hazards, including floods, sea level rise, droughts, and landslide.
- Stakeholders are discussing:
 - the Just Energy Transition exiting the coal mining industry and creating jobs in other industries;
 - o the Adaptive Social Protection Roadmap; and
 - the Long-term National Development Plan from 2025 to 2045.
- We are in a right moment to have this Forum and the Report that we launch today.
- Climate-related hazards can result in disruption of production and service activities, and physical damage to workplace. These events cause job-loss or disruptions to regular income of workers.
- Climate change greatly affects agriculture, fishing, forestry, tourism, wholesale, retail, restaurant, hotels, mining, and utilities.

- Globally, the framework of Adaptive Social Protection tends to focuses on social assistance. But the role of social insurance is equally important.
- On March 2022, the ILO and the GIZ agreed on the implementation of research activity to examine the role of social insurance within the framework of Active Social Protection approach.
- The ILO has been conducting the study with the Social Security Unit of Bappenas.
- To obtain inputs, we held bilateral meetings with BNPB and BPJS Employment in December 2022. We shared initial results and facilitated a tripartite meeting in January this year.
- The Report has analysis and recommendations on the Unemployment Insurance Scheme, the Pension Scheme, and the Employment Injury Insurance Scheme.
- Today, I am pleased to hand over this Report, analysis and recommendations to the Government of Indonesia and the ILO constituents.
- Social assistance traditionally protects poor and vulnerable households. But climate-related hazards do not only affect poor and vulnerable households but also middle-class workers, women and self-employed workers and any other ordinary residents. Social insurance can cover them and provide adequate protection.
- Social Insurance can address both short-term and longterm challenges.

- The Unemployment Insurance Scheme provides income to jobseekers moving from one industry to the other industry – moving from disaster affected towns to other towns.
- The investment of the social insurance fund can play an important role to facilitate a longer-term adaptation and Just Transition to an environmentally sustainable economy and society.
- I would like to acknowledge:
