Concept & Definitions:

- 1. Labour Force: The labour force is composed of the economically active population 10 years of age and over.
- 2 The Economically Active Population: is defined as those persons who are/were employed or unemployed during the reference period of the survey.
- 3. **Employed:** Persons, who worked as paid employees, employers, own account workers (self employed), or unpaid family workers during the referce period are said to be employed. This includes persons with a job but not at work during the reference period.
- 4. **Unemployed:** Persons available and/or looking for work, and who did not work and taken steps during last four weeks to find a job and ready to accept a job given a work opportunity within next two weeks.

5. Reference period:

Reference period "current": The week preceding the week of the survey; i.e. last week.

- 6. Not in the Labour Force (not economically active): Persons who were neither working nor available/looking for work are classified as "not in the labour force". Persons are not in the labour force for such reasons as: full time care of the household, full-time students, retired or old age, infirmed or disabled, or are not interested in working for one reason or another.(Current and usual definitions apply)
- 7. Underemployment is defined based on hours of work in his occupation/Economic activity. i.e. The persons who are willing and able to work beyond the total hours work.


